**INTERGOVERNMENTAL AGREEMENT BETWEEN
THE CITY ATLANTA, GEORGIA, AND FULTON COUNTY, GEORGIA**

2024 BYRNE JUSTICE ASSISTANCE GRANT ("JAG") PROGRAM AWARD

This Agreement is made and entered into this _____ day of _____, 2025, by and between FULTON COUNTY, GEORGIA, acting by and through, the Honorable Robb L. Pitts, Chair of the Fulton County Board of Commissioners, (hereinafter referred to as "the COUNTY") and the CITY OF ATLANTA, GEORGIA, acting by and through its Mayor, the Honorable Andre Dickens, (hereinafter referred to as "the CITY"), both of Fulton County, State of Georgia witnesseth:

WHEREAS, the 2024 Byrne Justice Assistance Grant ("JAG") Program provides funding to local governments to create safer communities and improve the functioning of the criminal justice system from the U.S. Department of Justice ("DOJ"); and

WHEREAS, a disparity in allocated 2024 JAG funding exists between the COUNTY and the CITY, and this disparity is recognized by the U.S. Department of Justice; and

WHEREAS, this disparity is the result of the fiscal burden the County bears for the state mandated prosecution and incarceration of all Part One felony cases in Fulton County, and US DOJ JAG regulations require that an understanding (or agreement) be reached between the CITY and the COUNTY regarding allocated 2024 JAG funding before an application may be submitted to US DOJ; and

WHEREAS, this Agreement is made under the authority of the Fulton County Board of Commissioners, 2025 Meeting Agenda Item No. 25-0794; and Atlanta City Council Resolution No. 24R4202; and

WHEREAS, each governing body, in performing governmental function or in paying for the performance of governmental function hereunder, shall make that performance or those payments from current revenues legally available to that party; and

WHEREAS, each governing body finds that the performance of this Agreement is in the best interests of the parties, that the undertaking will benefit the public, and that the division of costs fairly compensates the performing party for the services or functions under this agreement; and

WHEREAS, the CITY and the COUNTY agree to allocate \$80,585.00 of the City's \$348,130.00 allocation for the 2024 JAG grant to the COUNTY; and

WHEREAS, the CITY and the COUNTY agree that the CITY will apply for and administer the JAG grant on behalf of the CITY and the COUNTY; and

WHEREAS, the City of Atlanta agrees to require no additional compensation for administering the JAG grant program; and

WHEREAS, the COUNTY agrees to provide to the CITY quarterly reports as required by the DOJ; and

WHEREAS, the CITY and the COUNTY agree to the allocation of funds as set out in Section 1 below; and

WHEREAS, the CITY and COUNTY find it to be in their best interests to allocate the JAG funds as described and set forth herein.

NOW THEREFORE, the COUNTY and the CITY agree as follows:

Section 1.

The CITY and the COUNTY agree to allocate JAG funds in the amount of \$80,585.00 for projects to be reviewed and approved by DOJ from the CITY's allocation of \$348,130.00. The CITY will retain \$267,545.00 of the JAG award.

Section 2.

Nothing in the performance of this Agreement shall impose any liability for claims against the COUNTY other than claims for which liability may be imposed by statute or the Georgia General Assembly.

Section 3.

Nothing in the performance of this Agreement shall impose any liability for claims against the CITY other than claims for which liability may be imposed by statute or the Georgia General Assembly.

Section 4.

Each party to this agreement will be responsible for its own actions in providing services under this agreement and shall not be liable for any civil liability that may arise from the furnishing of the services by the other party.

Section 5.

The parties to this Agreement do not intend for any third party to obtain a right by virtue of this Agreement.

Section 6.

By entering into this Agreement, the parties do not intend to create any obligations express or implied other than those set out herein; furthermore, this Agreement shall not create any rights in any party not a signatory hereto.





CONSUMER DISCLOSURE

From time to time, Carahsoft OBO Fulton County, Georgia (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign, Inc. (DocuSign) electronic signing system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after signing session and, if you elect to create a DocuSign signer account, you may access them for a limited period of time (usually 30 days) after such documents are first sent to you. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format.
