WHEREAS, Fulton County ("County") entered into a Contract with **Axis Forensic Toxicology** to provide Forensic Postmortem Toxicology testing, dated January 1, 2022, on behalf of the Medical Examiner's office; and

WHEREAS, the Medical Examiner's Office seeks to increase the spending authority to cover an increase in opioid testing over the past year; and

WHEREAS, the Contractor has performed satisfactorily over the period of the contract; and

WHEREAS, this amendment was approved by the Fulton County Board of Commissioners on March 6, 2024, BOC#24-0168

NOW, THEREFORE, the County and the Contractor agree as follows:

This Amendment No. 1 to Form of Contract is effective upon BOC approval , between the County and Axis Forensic Toxicology, who agree that all Services specified will be performed in accordance with this Amendment No. 1 to Form of Contract and the Contract Documents.

1. **SCOPE OF WORK TO BE PERFORMED:** This request is due to an increase in suspected opioid related deaths over the past 2 years that precipitated the need for additional testing beyond the original contract amount.
2. **COMPENSATION:** The services described under Scope of Work herein shall be

performed by Contractor for a total amount not to exceed \$15,000.

3. **LIABILITY OF COUNTY:** This Amendment No. 1 to Form of Contract shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the Chair to the Commission, attested to by the Clerk to the Commission and delivered to Contractor.
4. **EFFECT OF AMENDMENT NO. 1 TO FORM OF CONTRACT:** Except as modified by this Amendment No. 1 to Form of Contract, the Contract, and all Contract Documents, remain in full force and effect.

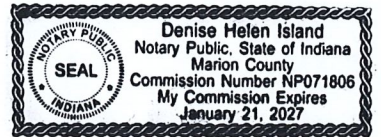
