The Community Violence and Intervention and Prevention Initiative will break the cycle of individuals involved in criminal activity, and reduce recidivism, which improves community safety. The program will provide community-based case management and wraparound supportive services to participants' families, ending the cycle as children of incarcerated parents through Fulton County Community Partners.
