WHEREAS, Fulton County (“County”) entered into Contract with Arbor E&T, LLC dba Equus Workforce Solutions (Equus) to provide the WIOA authorized case management and career services for adults, dislocated workers, and a comprehensive program design and service strategies for youth. This is s a part of the “One-Stop Delivery System” services, dated April 20th, 2022, on behalf of the Economic Development Department; and

WHEREAS, the Consultant shall provide additional changes to the existing Scope of Work due to the County’s partnership with WorkSource Metro Atlanta to carry out Virtual One-Stop services.

WHEREAS, the Contractor has performed satisfactorily over the period of the contract; and

WHEREAS, this amendment was approved by the Fulton County Board of Commissioners on [Insert Board of Commissioners approval date and item number].

NOW, THEREFORE, the County and the Contractor agree as follows:

This Amendment No. 1 to Form of Contract is effective as of the December day of 21, 2022, between the County and Arbor E&T, LLC dba Equus Workforce Solutions who agree that all Services specified will be performed in accordance with this Amendment No. 1 to Form of Contract and the Contract Documents.

1. **SCOPE OF WORK TO BE PERFORMED:** amend existing contract – Department of Economic Development, Bid# 22RFP0121B, Adult and Dislocated Worker Services, to increase the spending authority in the amount of \$697,000.00 via the

COVID-19 National Emergency Grant to serve eligible Dislocated Workers which increases the total contract amount to \$1,725,125.00 to provide WIOA authorized “career services” delivery for eligible Adult and Dislocated Worker Services to serve Fulton county residents. Contractor Arbor E&T, LLC dba Equus Workforce Solutions (Equus) (Louisville, KY), provides adult and dislocated career center services. This action amends the contract total from \$1,028,125.00 to \$1,725,125.00. Three renewal options remain. Effective dates: July 1, 2022 through June 30, 2023.

2. **COMPENSATION:** The services described under Scope of Work herein shall be performed by Contractor for a total amount not to exceed \$1,725,125.00.
3. **LIABILITY OF COUNTY:** This Amendment No. 1 to Form of Contract shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the Chair to the Commission, attested to by the Clerk to the Commission and delivered to Contractor.
4. **EFFECT OF AMENDMENT NO. 1 TO FORM OF CONTRACT:** Except as modified by this Amendment No. 1 to Form of Contract, the Contract, and all Contract Documents, remain in full force and effect.

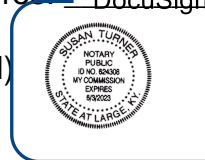
