Proceedings:

The meeting was called to order at 8:42 a.m. by Chairperson Whitner.

Agenda:

Chairperson Whitner made a motion to move the Grounds Committee report first on the agenda. Ms. Falconer second the motion. Motion CARRIED.

Grounds, Facilities and Security Committee Report

Sink Hole Repair

Mr. Kendall informed the board of the emergency sink hole repair completed at Fanplex.

Use of the Facility

The committee recommends approval of a special event rental rate at \$2,500.00 and a refundable clean-up fee of \$2,500.00. The group would be responsible for hiring Atlanta Police Officers for events after 5:00 p.m. and obtain a liquor license. Mr. Heard second the motion. Motion CARRIED.

Grey Lot Repairs

The committee recommends approval of continued repairs by Reese Construction Company in the amount of \$62,675.00. Mr. Heard second the motion. Motion CARRIED.

The First Tee of Atlanta Board Appointee

The committee recommends and approves appointment of Geoffrey Heard to the Board to replace Tony Terrell. Ms. Falconer second the motion. Motion CARRIED.

Learning Center

The First Tee of Atlanta is scheduled to meet with Chairperson Whitner and Mr. Kendall to discuss funding requirements.

Connect South Fulton

Mr. Arrington made a motion to approve Connect South Fulton's funding request of \$10,000.00 to purchase and install security cameras and lighting in support of the Princeton Lakes Public Walking Trail Project. The approval is subject to Mr. Kendall and Mr. Davis discussing details about acknowledgment of AFCRA's contribution. Mr. Heard and Ms. Falconer abstained. Mr. Green second the motion. Motion CARRIED.

Zoo Atlanta

Mr. Arrington made a motion that approval of the food concession contracts is contingent upon a meeting with Zoo officials and agreeance on terms of the contracts. Mr. Heard second the motion. Motion CARRIED.

Philips Arena

Renovations

Mr. Kendall explained that the renovations are on schedule. AFCRA Suite will be finished in three to four weeks.

Girls/Boys Basketball Tournament

Mr. Arrington made a motion to authorize Mr. Kendall review at least three proposals and select an event planner. In addition, establish a budget and timeline. Mr. Heard second the motion. Motion CARRIED.

Office Furniture

Mr. Kendall and the executive assistant will conduct further review of the furniture proposals submitted and report back to the Board.

Audit and Finance Committee Report

The committee will schedule a meeting in the coming weeks to discuss the status of the 2017 Audit and review and make a recommendation for a new auditor.

Community Recreation Special Project Committee Report

The committee will come up solutions for the use of Fanplex.

Community Environmental Concerns

Dr. Jane Ridley, Columbus Ward and Dr. Yomi Noibi explained concerns about air pollution levels in the S.M.P. communities. Mr. Ward added that there is an increase in the number of children diagnosed with Asthma. Ms. Ridley's recommendation is that AFCRA build parking decks on lots that it owns. Mr. Ward added that these communities would like to be a part of the redevelopment process.

Executive Session

Mr. Green made a motion to move into executive session to discuss real estate and personnel. Mr. Arrington second the motion. Motion CARRIED.
