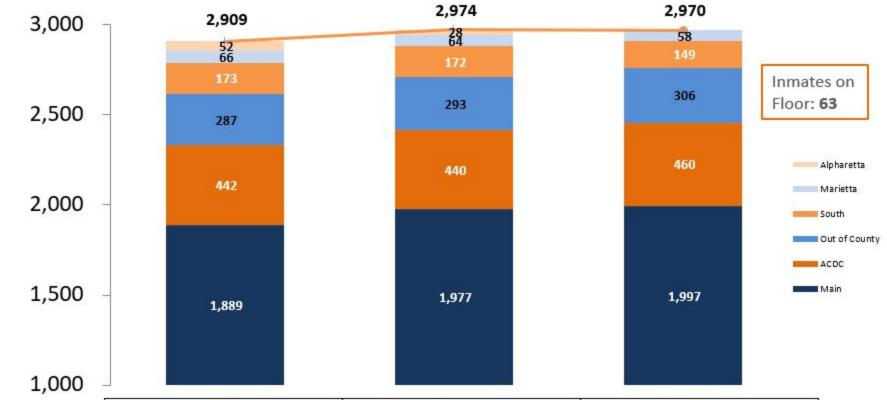

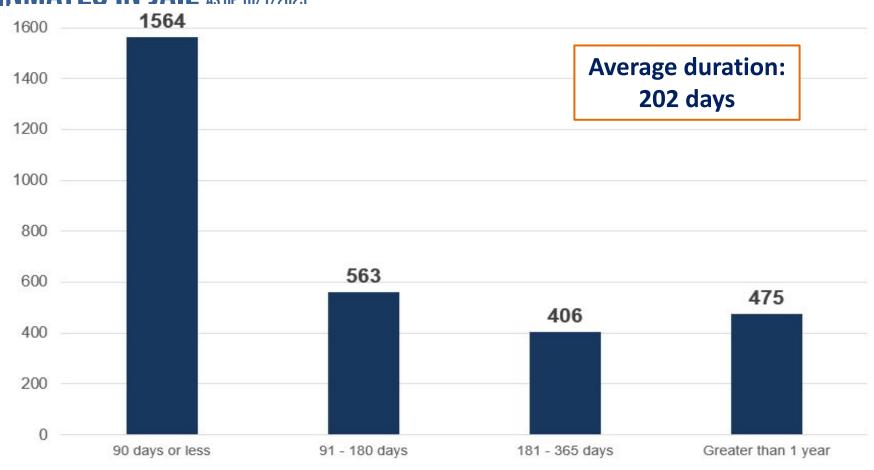

LENGTH OF STAY FOR CURRENTLY INCARCERATED



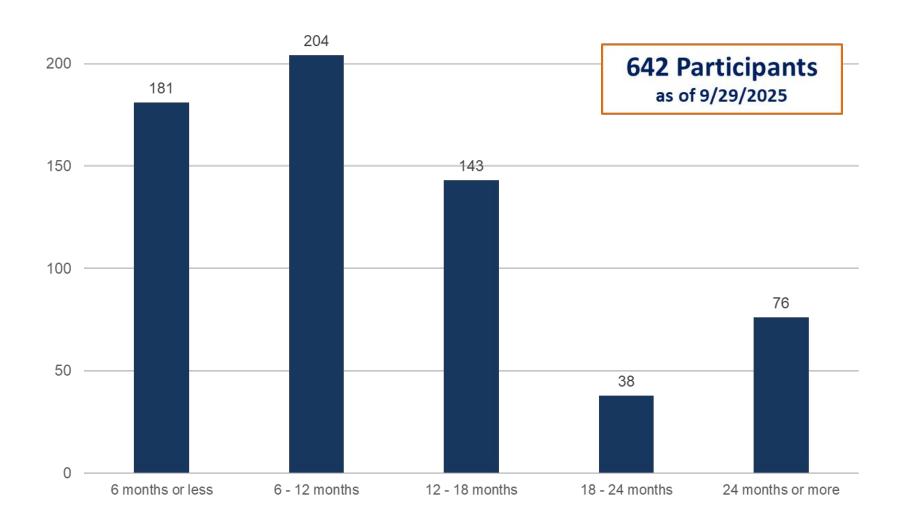
INMATES IN JAIL AS NF 10/1/2025

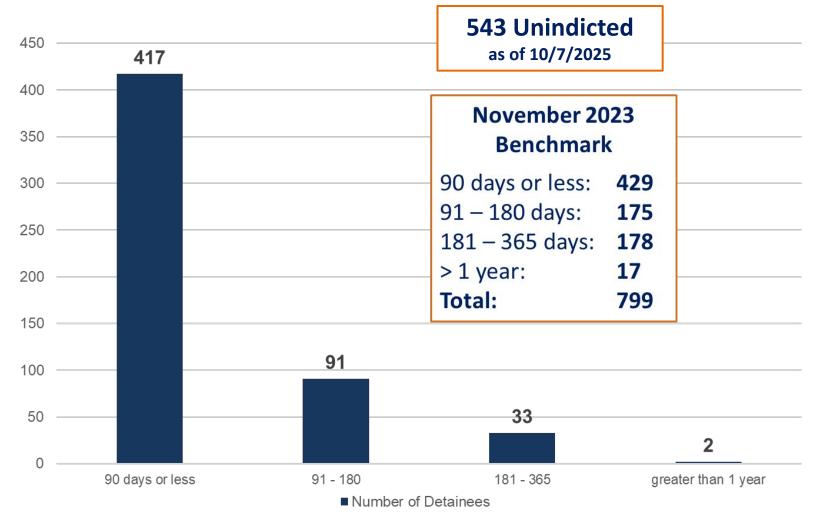

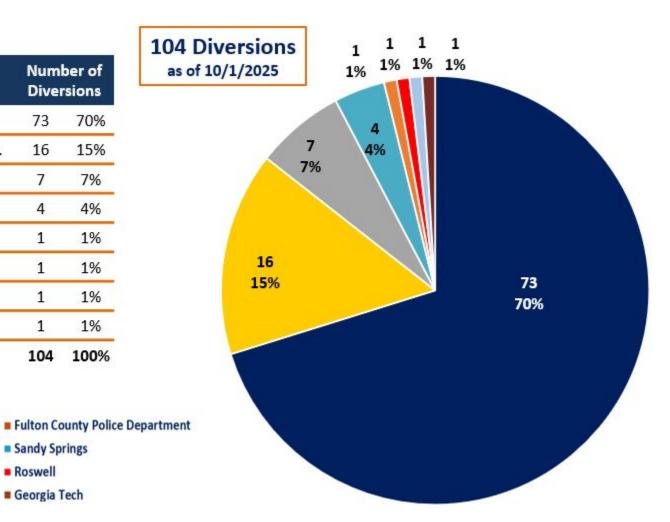

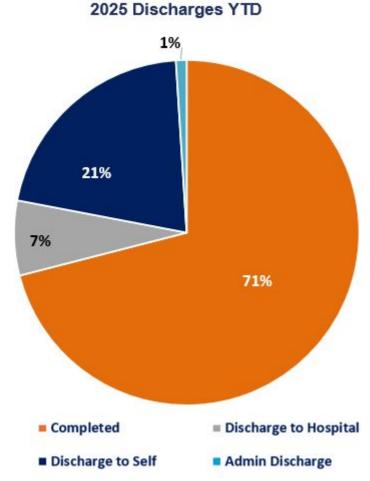


2025 DIVERSIONS YTD DIVERSIONS & DISCHARGES AS OF 10/1/2025

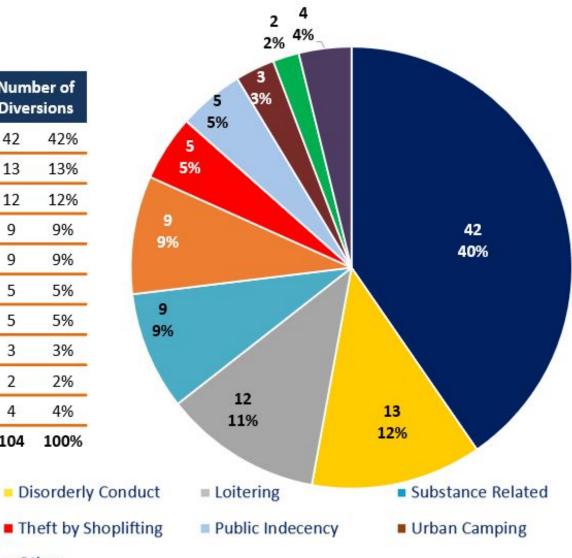

Overall Blitz Project Update

- o 9 of 11 housing units completed = 82%
- O 3 North completed on August 14, 2025
- Current blitz areas: 3 South & 7 South
 - FCSO determined that 7 South was critical for housing maximum security classification residents
 - 3 South critical for housing residents requiring physical and behavioral health concerns.
- Phase 1 blitz completion: Mid-November
 2025
- Phase 2 Blitz to begin in Q1 2026

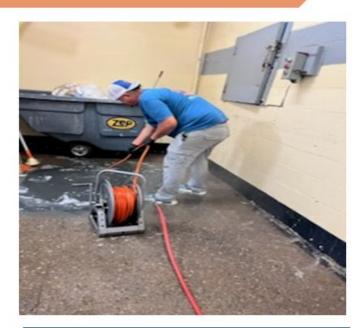

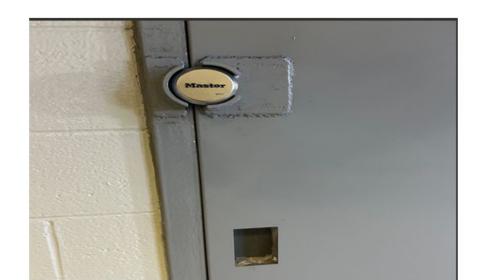


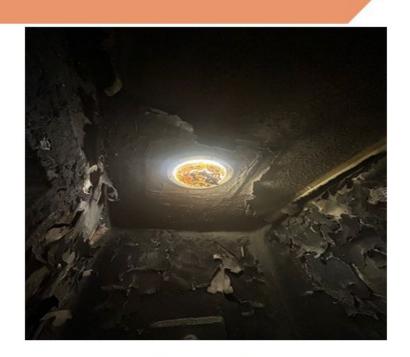
Action Taken/Next Steps

- EMSI conducts monthly analysis of maintenance performance data.

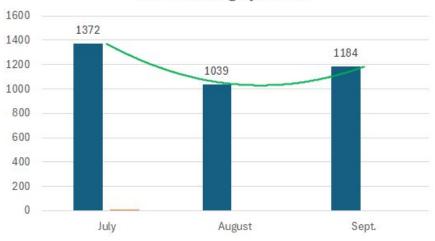
Work Order Backlog

- On average, 1,500 work orders created each month
 - o 800 work orders submitted by EMSI per month
 - Approx. 700 work orders per month are initiated by FCSO staff
- Maintenance averaging 1,200 completed work orders per month
 - Average time to complete = 2.5 days
 - Base contract staffing = 18 technicians
 - Backlog goal of < 500 open work orders by December 2025.
