WHEREAS, Fulton County ("County") entered into a Contract with Universal Protection Services dba Allied Universal Security Services ("Contractor") to provide armed and unarmed security services for Fulton County Government facilities dated January 1, 2022 on behalf of the Fulton County Police Department; and

WHEREAS, the County desires to amend the existing contract to revise the hourly rates for certain position titles and to allow the Police Department to make adjustments to security staff personnel for each position title as determined by the Police Department to ensure sufficient staffing is provided to ensure security coverage for all County facilities; and

WHEREAS, the Contractor has performed satisfactorily over the period of the contract; and

WHEREAS, this amendment was approved by the Fulton County Board of Commissioners on April 20, 2022; BOC #22-0278

NOW, THEREFORE, the County and the Contractor agree to amend the Agreement as follows:

This Amendment No. 2 to Form of Contract is effective on 13th day of April 2022 between the County and Contractor who agree that all Services specified will be performed in accordance with this Amendment No. 2 to Form of Contract and the Contract Documents.

1. **SCOPE OF WORK TO BE PERFORMED:** To amend the contract to revise the hourly rates for certain position titles and to allow the Police Department to make

adjustments to security staff personnel for each position title as determined by the Police Department to ensure sufficient staffing is provided to ensure security coverage for all County facilities.

2. **COMPENSATION:** No additional funding is required.
3. **LIABILITY OF COUNTY:** This Amendment No. 2 to Form of Contract shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the Chair to the Commission, attested to by the Clerk to the Commission and delivered to Contractor.
4. **EFFECT OF AMENDMENT NO. 2 TO FORM OF CONTRACT:** Except as modified by this Amendment No. 2 to Form of Contract, the Contract, and all Contract Documents, remain in full force and effect.

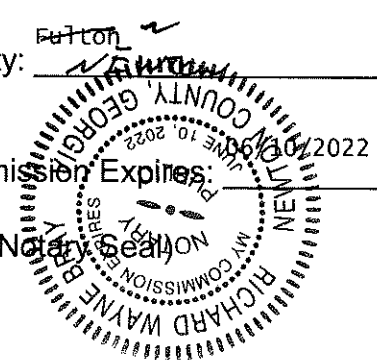
