WHEREAS, Fulton County ("County") entered into a Contract with Hogan Construction Group, LLC, to provide Design/Build Services for the Peachtree Library Renovation Project, dated November 16, 2022, on behalf of the Department of Real Estate and Asset Management; and

WHEREAS, this change order is required to make modification to the existing Contract for additional funding due to price escalation in construction costs for the Design/Build Services for renovation project for the Peachtree Library in which these increase costs occurred after the renovation project was budgeted.

1. SCOPE OF WORK TO BE PERFORMED: Modify the existing Contract for additional funding due to escalation in construction costs submitted by Hogan Construction, LLC to provide Design/Build Services through all phases of design

- and construction for the renovation of the approximately 9, 520 sq. ft. Peachtree Library.
- COMPENSATION: The services described under Scope of Work herein shall be performed by Contractor for a total amount not to exceed \$137,678.00 (One Hundred Thirty Seven Thousand Six Hundred Seventy Eight Dollars and Zero Cents).
- 3. **LIABILITY OF COUNTY:** This Change Order No. 1 to Form of Contract shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the Chair to the Commission, attested to by the Clerk to the Commission and delivered to Contractor.
- 4. **EFFECT OF CHANGE ORDER NO. 1 TO FORM OF CONTRACT:** Except as modified by this Change Order No. 1 to Form of Contract, the Contract, and all Contract Documents, remain in full force and effect.
