RESOLUTION TO APPROVE THE TRANSFER OF \$15,000 FROM CHAIRMAN 1 2 PITTS' TRAVEL LINE ITEM TO THE CSP GRANTS AWARDS FOR THE 3 PURPOSE OF PROVIDING HOSEA FEED THE HUNGRY AND 4 HOMELESS, INC. \$15,000 TO USE TOWARDS ITS MISSION. 5 WHEREAS, pursuant to O.C.G.A. § 36-1-19.1, Fulton County is authorized to 6 7 make appropriations for purely charitable purposes, which shall include charitable, 8 benevolent, or philanthropic purposes for health, education, social welfare, arts and 9 humanities or environmental organizations; and 10 WHEREAS, the Fulton County Board of Commissioners aims to combat 11 homelessness and poverty through the development and coordination of programs and 12 supportive services: and 13 WHEREAS, the Fulton County Board of Commissioners approved the 2020 14 Community Services Program's ("CSP") funding recommendation in the amount of 15 \$5,363,958 at its March 4, 2020 Regular Meeting; and WHEREAS, Hosea Feed the Hungry and Homeless, Inc. is a private non-profit 16 organization that aims to restore and re-stabilize at risk and homeless individuals and 17 18 families so they can thrive and become self-sufficient; and 19 WHEREAS. Hosea Feed the Hungry and Homeless, Inc. was funded in the 20 amount of \$61,048.00, pursuant to the 2020 CSP; and 21 WHEREAS, the costs associated with combating homelessness and programs 22 are increasing and demand greater commitment and provision of resources; and 23 WHEREAS, the Fulton County Board of Commissioners desires to connect all Fulton County residents to the proper resources that aid and support their goals for 24 25 housing, care and self-sufficiency.

1	NOW THEREFORE, BE IT HEREBY RESOLVED, that in addition to the amoun			
2	recommended to be awarded to Hosea Feed the Hungry and Homeless, Inc. through			
3	the 2020 CSP, the Chairman of the Board of Commissioners authorizes the Fulton			
4	County Department of Finance to transfer \$15,000 from his Commissioner's budget to			
5	increase the funding for Hosea Feed the Hungry and Homeless, Inc. for othe			
6	administrative needs to support the facilities that they utilize for their programs.			
7	BE IT FURTHER RESOLVED that this Resolution shall become effective upor			
8	its adoption, and that all resolutions and parts of resolutions in conflict with this			
9	Resolution are hereby repealed to the extent of the conflict.
