## **Pallet Racking – Fulton County**

### **Scope of Work:**

All Bays are very similar to existing racking. All are 42" deep with 8' wide beam levels – 4,000 lb capacity per level. All levels are wire decked. Each end of row will be protected with end of rack guarding. Also included are cages for PPE and IT and Rack back to protect an office in the Equipment Cage

### **Racking Breakdown:**

Retention Cage: 11 bays 12' high with three (3) beam levels

Supply and Packing Cage: 19 bays 12' high with four (4) beam levels (2 hand pick)

Equipment Cage: 8 bays 12' high with two (2) beam levels. Rack Back on 4 bays

PPE and IT Cage: 36 bays 28' high with four (4) beam levels. Two Cages in this area

Material Cost = \$52,098.00

Installation = \$6,420.00 (including lift equipment)

Freight = \$1,667.00

**Rack Backing in Equipment Cage:**

Four (4) bays of Wire Rack Backing to protect office. Fence runs from floor to 16'.  
Racking proposed is 12' high.

Material Cost, Delivered = \$5,452.00  
Installation = \$425.00 (with racking install)

**PPE and IT Cages:**

Both cages are the same. 3- sided with ceiling. Each is 17' out from wall x 20' wide with an 8' x 10' high slide gate. Standard key lock

Materials Cost, Delivered Each = \$17,430.00 x 2 = \$34,860.00  
Installation = \$3,600.00 total

**Pricing Summary:**

Material Cost = \$92,410.00  
Installation = \$10,445.00 (including lift equipment)
