WHEREAS, Fulton County ("County") entered into a Contract with Abacus Corporation to provide Temporary Staffing Services - Clerical & Light, BOC approved June 18, 2025, Item No. 25-0468, on behalf of the Registration & Elections Department; and

WHEREAS, the County wishes to amend the existing contract to provide Temporary Staffing Services - Clerical & Light in the additional amount of \$352,000 with to cover the cost of additional work hours and staffing to conduct the Senate District 35 election and runoff, which was not included in the original 2025 election calendar; and

WHEREAS, this amendment was approved by the Fulton County Board of Commissioners on December 3, 2025, BOC Item no. 25-0929, and.

NOW, THEREFORE, the County and the Contractor agree as follows:

This Amendment No. 2 to Form of Contract is effective as of December 3, 2025, between the County and Abacus Corporation, who agree that all Services specified will be performed in accordance with this Amendment No.2 to Form of Contract and the Contract Documents.

1. **SCOPE OF WORK TO BE PERFORMED:** to provide Temporary Staffing Services

- Clerical & Light in the additional amount of \$352,000.00 with to cover the cost of additional work hours and staffing to conduct the Senate District 35 election and runoff election, which was not included in the original 2025 election calendar.
2. **COMPENSATION:** The services described under Scope of Work herein shall be performed by Contractor for a total amount not to exceed \$352,000 approved by BOC.
 3. **LIABILITY OF COUNTY:** This Amendment No.2 to Form of Contract shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the Chair to the Commission, attested to by the Clerk to the Commission and delivered to Contractor.
 4. **EFFECT OF AMENDMENT NO.1 TO FORM OF CONTRACT:** Except as modified by this Amendment No. 2 to Form of Contract, the Contract, and all Contract Documents, remain in full force and effect.
