

SUBJECT: Recommendation Award – ITB #22ITB132332C-GS, Solid Waste Disposal and Recycling Services Countywide-FY2022

Recommendation: We are recommending approval of the lowest responsible bidders for Bid#22ITB132332C-GS, Solid Waste Disposal and Recycling Services Countywide in the total amount of \$754,600 with (A) Latham Home Sanitation Company, Inc. (Loganville, GA) in the amount of \$441,600; and (B) Georgia Waste Systems, LLC dba Waste Management of Atlanta South, (Like City, GA) in the amount of \$313,000, to provide landfill solid waste disposal; and single stream recycling services for Fulton County facilities, Effective dates: April 1, 2022, through December 31, 2022, with two (2) renewal options.

DISCUSSION: The recommendation for award was based on the bidders' lowest total cost per container size group, which consists of four (4) different groups: 1. 95 Gallon for Recycling Services, 2. 95 Gallon for Solid Waste Disposal Services for Libraries, 3. 8 Yard Front Loader for Solid Waste Disposal Services, and 4. Open Top & Compactors for Solid Waste Disposal Services. Also, the lowest bidder for Shredding Services. The bidder must bid on all facilities type listed within each container size group to be considered for an award. Total Cost for each Container Size Group(s) and Shredding Services to determine the total based bid amount.

The Department received and evaluated two (2) bid responses to the solicitation.

Evaluation Process:

1. **Latham Home Sanitation Company, Inc.:** submitted the overall lowest responsible and responsive bids for: 95 Gallon Recycling Services, which consists of 13 different facilities types and two different open tops/compactors type facilities; 95 Gallon Solid Waste Disposal Services for Libraries, which consists of 34 libraries countywide; and Shredding Services Countywide.
2. **Georgia Waste Systems, LLC.** submitted the overall lowest responsible and responsive bids for: 8 Yard Front Loader, which consists of 12 different facilities type groups and Open Top & Compactors, which consists of six other facilities for Solid Waste Disposal Services.

Conclusion:


Therefore, we recommend Latham Home Sanitation Company, Inc. and Georgia Waste Systems, LLC. to be awarded as the lowest responsible bidders to provide solid waste disposal services for Fulton County facilities for FY2022 with effective dates: April 1, 2022, through December 31, 2022.


These bidders have a current contract with Fulton County and has performed very good and highly competent as a Janitorial Contractors for Fulton County as stated in their performance reports.
