- 1. <u>INDUCEMENT RESOLUTION</u> OF THE ATLANTA DEVELOPMENT AUTHORITY D/B/A INVEST ATLANTA DECLARING ITS INTENTION TO ISSUE NOT TO EXCEED \$15,000,000 IN ORIGINAL AGGREGATE PRINCIPAL AMOUNT OF ATLANTA DEVELOPMENT AUTHORITY TAXABLE LEASE PURCHASE REVENUE BONDS IN ONE OR MORE SERIES TO FINANCE THE ACQUISITION, CONSTRUCTION, INSTALLATION AND EQUIPPING OF A REAR-LOAD WAREHOUSE FOR **AMB HARTSFIELD EAST DISTRIBUTION CENTER, LLC**; AND OTHER RELATED MATTERS.
