In accordance with the Purchasing Code, a duly appointed Evaluation Committee has reviewed the proposals submitted in response to the above-reference project on behalf of the Department of Real Estate and Asset Management.

Four (4) qualified firms submitted proposals for evaluation and consideration for award of this project:

1. Control Concepts, LLC
2. Johnson Controls, Inc.
3. Trane US, Inc.
4. Maxair, Inc.

After review and scoring of the Technical Proposal, only three (3) of the four (4) firms were found to be reasonably susceptible for award. Oral Interviews were held with Control Concepts, LLC, Johnson Controls, Inc. and TRANE U.S., Inc.

2. Johnson Controls, Inc.
3. TRANE U.S., Inc.

After Oral Interviews with the three firms listed above, **Control Concepts, LLC** scored the highest overall and the Evaluation Committee chose to negotiate with them. The evaluation of the Negotiation and consideration of all available information related to the requirements set forth in the evaluation criteria of the RFP has determined that the proposal submitted by **Control Concepts, LLC**, with a score of **84.55%** is the recommended vendor for the award of #20RFP041620K-CRB - Fulton County Judicial Center Complex DDC Conversion Project - Phase II.
