FULTON COUNTY TRANSITION FROM ATTORNEY ADVANCED BUNDLE TO AXON JUSTICE

Over the past four years, Fulton County has utilized Axon's Attorney Advanced Bundle (AAB) to provide its Justice Agencies (District Attorney, Solicitor General, and Public Defender) with foundational tools for managing digital evidence. That program has expired.

As part of Axon's ongoing innovation in digital evidence management, Fulton County will transition to Axon Justice, which delivers a modern, purpose-based experience designed specifically for prosecutors, defense attorneys, and courts. This upgrade introduces powerful new capabilities while maintaining continuity for current users and data.

The following new features are included in Axon Justice

- ▶ Data continuity: All existing evidence, storage, and accounts remain in place. No data migration is required.
- ▶ User continuity: Current logins and administrator tools remain intact. Many familiar admin screens will not change.
- ▶ Core functionality: Unlimited storage and evidence management for DA, SG, and PD continues under the new program.

AI & AUTOMATION

- ▶ BriefOne AI Summaries: Automatically generates case-specific evidence summaries to reduce review time.
- ▶ Automated Translation: Instantly translates multilingual evidence to accelerate case prep.
- ▶ AI Auto-Redaction: Continue with expanded AI functionality to speed sensitive data handling.



/ CASE-BASED WORKFLOWS

- ▶ Purpose-Built User Experience: Attorneys, defense, and courts now operate in a case-based system tailored to their role.
- ▶ Advanced Case Organization: Windows-style folders and improved search (Case Search 2.0) make finding and managing evidence faster.

/ EVIDENCE INGESTION & SHARING

- ▶ Universal Upload Portals: Law enforcement agencies—regardless of vendor or body-cam system—can securely upload digital evidence directly into prosecutor cases.
- ▶ Ad-Hoc Uploads: Prosecutors, defense, and courts can invite uploads from civilians, businesses, or law enforcement on a case-by-case basis.
- ▶ Discovery & Disclosure: Purpose-based tools streamline disclosure to defense, including cloud-to-cloud sharing with bar members, eliminating paper, flash drives, or physical media.
- ▶ Public Defender Integration: PDs can establish disclosure portals with prosecutors at no added cost to law enforcement or defense members.

/ NEW SPECIALIZED TOOLS

- ▶ Cell Phone Extraction Viewer: Intuitive review of mobile device data such as texts, call logs, and app data.
- ▶ Policy Chat: AI-assisted tool that answers staff policy questions by referencing agency documents.

/ VALUE TO FULTON COUNTY

- ▶ A case-centric, purpose-built platform designed for prosecutors, defense, and courts.
- ▶ Faster, AI-powered evidence review that reduces workload and costs.
- ▶ Broader connectivity with law enforcement, defense, and bar members through secure cloud-based portals.
- ▶ Future-proof innovation while keeping existing systems, data, and workflows stable.
- ▶ Centralized digital evidence management by **eliminating four legacy data sources** and consolidating all evidence into one unified system. This enables offices to leverage the full power of Axon Justice features across all case files.
- ▶ End-to-end digital disclosure: Fulton County can now move away from local storage, hard drives, and thumb drives—which often fail to preserve metadata or degrade over time—and instead share evidence cloud-to-cloud between prosecutors, defense, and courts.
