WITNESSETH

WHEREAS, Fulton County ("County") entered into a Contract with Veolia North America, LLC., to provide operation and maintenance services at wastewater facilities and pump stations in North Fulton, dated 19th day of February 2020, on behalf of the Department of Public Works; and

WHEREAS, the County wishes to extend the existing contract to provide reliable, uninterrupted operation of the water and wastewater system operations and maintenance management systems in the North Fulton service area; and

WHEREAS, the Contractor has performed satisfactorily over the period of the contract; and

WHEREAS, this amendment was approved by the Fulton County Board of Commissioners on October 15, 2025; Item #25-0787.

NOW, THEREFORE, the County and the Contractor agree as follows:

This Amendment No. 3 to Form of Contract is effective November 4, 2025, through December 31, 2025, or until services are no longer required as determined by Fulton County. This Amendment is entered into by and between Fulton County and Veolia North America, LLC, who agree that all services specified shall be performed in accordance with this Amendment No. 3 and the Contract Documents.

1. **SCOPE OF WORK TO BE PERFORMED:** Veolia Water North America operates all of the North Fulton assets, including 3 wastewater treatment facilities, all wastewater lift stations, and all water pump stations. The extension will continue the same three financial elements of the original contract - a Fixed Base Service Fee, Maintenance Allowance, and Contingency Allowance. This contract extension will allow for Veolia Water North America-South to continue to operate these facilities without interruption.

2. **COMPENSATION:** The services described under Scope of Work herein shall be performed by Contractor in an amount not to exceed \$3,506,212.72 (Three Million Five Hundred Six Thousand Two Hundred Twelve Dollars and Seventy-Two Cents).
3. **LIABILITY OF COUNTY:** This Amendment No. 3 to Form of Contract shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the Chair to the Commission, attested to by the Clerk to the Commission and delivered to Contractor.
4. **EFFECT OF AMENDMENT NO. 3 TO FORM OF CONTRACT:** Except as modified by this Amendment No. 3 to Form of Contract, the Contract, and all Contract Documents, remain in full force and effect.




