WHEREAS, Fulton County ("County") entered into a Contract with Latham Home Sanitation Company, Inc., to provide Solid Waste Disposal and Recycling Services Countywide, dated 1st day of April 2025, on behalf of the Department of Real Estate and Asset Management; and

WHEREAS, the County wishes to amend the existing contract to increase the spending authority to cover the costs for additional solid waste disposal and recycling services for Fulton County facilities; and.

WHEREAS, the Contractor has performed satisfactorily over the period of the contract; and

WHEREAS, this amendment was approved by the Fulton County Board of Commissioners on August 5, 2026, BOC Items #26-.

NOW, THEREFORE, the County and the Contractor agree as follows:

This Amendment No. 1 to Form of Contract is effective as of the 5th day of August 2026, between the County and Arrow, Inc. dba Arrow Waste, who agree that all Services specified will be performed in accordance with this Amendment No. 1 to Form of Contract and the Contract Documents.

1. **SCOPE OF WORK TO BE PERFORMED:** To cover the costs for additional solid waste disposal services due to vacant site clean-ups, illegal dumping and recycling services Countywide and to help sustain solid waste services for the remainder of FY2026.

2. **COMPENSATION:** The services described under Scope of Work herein shall be performed by Contractor for a total amount not to exceed \$25,000.00 (Twenty-Five Thousand Dollars and Zero Cents).
3. **LIABILITY OF COUNTY:** This Amendment No. 1 to Form of Contract shall not become binding on the County, and the County shall incur no liability upon same until such agreement has been executed by the Chair to the Commission, attested to by the Clerk to the Commission and delivered to Contractor.
4. **EFFECT OF AMENDMENT NO. 1 TO FORM OF CONTRACT:** Except as modified by this Amendment No. 1 to Form of Contract, the Contract, and all Contract Documents, remain in full force and effect.
