WHEREAS, Fulton County ("County") entered into a Contract with Archer Western-Brown and Caldwell Joint Venture to provide/perform progressive design/build (PDB) services on behalf of the Public Works; and

WHEREAS, the Contractor has performed satisfactorily over the period of the contract: and

WHEREAS, this Extension was approved by the Fulton County Board of Commissioners on the 1<sup>st</sup> day of October 2025 Item #25-XXXX.

**NOW**, **THEREFORE**, the County and the Contractor agree as follows:

This Extension No. 6 to Form of Contract is effective as of the 1st day of October 2025 between the County and Archer Western-Brown and Caldwell Joint Venture, who agree that all Services specified will be performed in accordance with this Extension No. 6 to Form of Contract and the Contract Documents for an additional period, with the contract ending as of the October 31st, 2025.

- COMPENSATION: The services described under Scope of Work herein shall be performed by Contractor for a total amount not to exceed amount of \$4,810,722.37 (Four Million Eight Hundred Ten Thousand Seven Hundred Twenty Two Dollars and Thirty Seven Cents) which is the final payment required to complete the work under this contract.
- 2. **LIABILITY OF COUNTY:** This Extension No. 6 to Form of Contract shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the Chair to the Commission, attested to by the Clerk to the Commission and delivered to Contractor.
- 3. **EFFECT OF EXTENSION NO. 6 TO FORM OF CONTRACT:** Except as modified by this Extension No. 6 to Form of Contract, the Contract, and all Contract Documents, remain in full force and effect.
