Approval of the Fulton County Board of Registration and Elections (FCBRE) increased compensation. The requested increases are \$300 per month for the chairperson of the FCBRE and \$250 per month for other board members.

In accordance with Article II, section 14-43, The compensation of each member of the board, the elections supervisor, any clerical assistants, and other employees of the board shall be fixed by the governing authority of Fulton County and shall be paid wholly from county funds.

Summary & Background

At the September meeting, the Fulton County Board of Registration and Elections (FCBRE) voted 3-1, with one abstention, to request a new compensation structure. The stipend for FCBRE members has been \$50 per meeting for at least 25 years. During elections, Board members are asked to attend three meetings per month, and between meetings frequently respond to requests or complaints from voters and review information pertaining to the Board. In 2015, the FCBRE met 30 times.

The FCBRE surveyed the election board compensation for ten metro counties, of which only Douglas County pays the lowest amount of \$50 per meeting, and Cherokee County pays the highest amount of \$350 for the chairperson and \$300 per Board member, per month.

The requested increase to \$300 per month for the chairperson of the FCBRE and \$250 per month for other board members would make FCBRE compensation comparable to the majority of metro county election boards, effective January 1, 2019.
