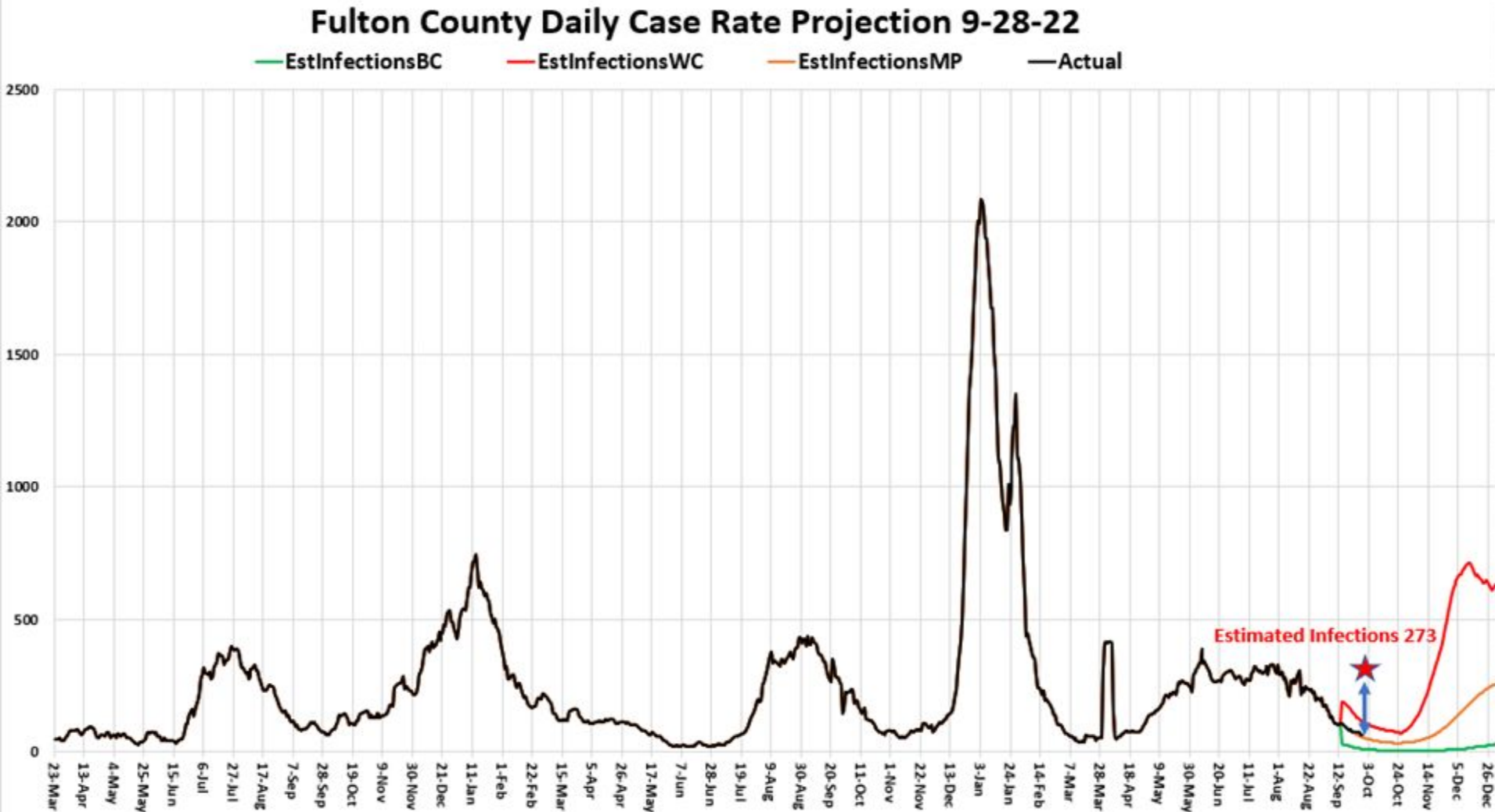
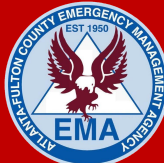
**Unvaccinated still

- ❖ Hospitalizations continue to slowly drop
- ❖ Currently there are 130 COVID patients in FC Hospitals
- ❖ FC hospitals still have 17 COVID patients on ventilators.

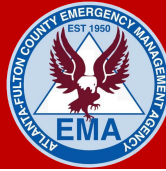
- ❖ **CDC Health System Risk is Green**
The lowest risk level – 3rd week
- ❖ **CDC community spread level is Orange**
The medium risk level – 2nd consecutive week

COVID Case Projection



- ❖ County Case-Rate continues to slowly drop as does the waste-water analysis
- ❖ Current modeling suggests a winter surge starting in mid-November

Bivalent COVID-19 boosters NOW available at all BOH sites!!!

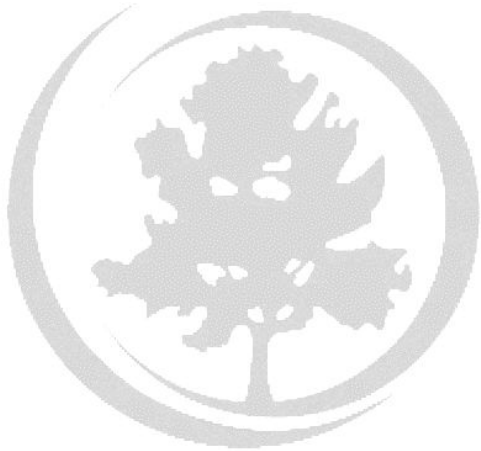
Eligibility - 12 y/o and over & 2 months since your last booster

Path Forward

- ❖ Monitor world, national, state and local trends
- ❖ Leverage waste-water sampling analysis and data
- ❖ Maintain relationships with key partners (E.G. school systems, hospitals, churches, senior services, etc.)
- ❖ Transition from contracted resources (E.G. CORE) to Board of Health services for fixed and mobile vaccination efforts
- ❖ Maintain key roles in our Unified Command system that we share with between Emergency Management and Board of Health (E.G. Unified Incident Command, Operations, Planning, and Logistics)
- ❖ Continue financial recovery efforts with GEMA and FEMA
