

#### PROGRAMS FOR ADULTS

- Currently, the Center for Health & Rehabilitation & South Fulton Service Center are open three days per week for in person services for new & existing clients. The North Fulton Service Center is open two days per week.
- With modified in person scheduling & telehealth services, the Fulton County Department of Behavioral Health and Developmental Disabilities (BHDD) provided services to 1,569 individuals from January 1, 2021 - June 30, 2021 and completed 13,440 total client activities.

#### TELE-HEALTH SERVICES

A modified in person schedule continued during the third quarter to offer onsite behavioral health services to clients in need of psychiatric & nursing services for both new and existing clients at the Center for Health & Rehabilitation & South Fulton Service Center three days per week. North Fulton Service Center is open for in person behavioral health services two days per week. Telephonic & telehealth services are being offered to clients to minimize in person contacts. From January 1st - September 30th, of the 13,440 total service contacts, they were rendered either via telephonic or telehealth means (8,492) and/or face to face/in person (4,948). Ultimately, 63% of services delivered thus far in 2021 were completed through telehealth.


#### **MINORITY AIDS INITIATIVE**

From July 2021 - September 2021, the C.L.A.S.S. program had 19 new participants, that were either positive for HIV or at high risk of becoming positive, introduced to services. Currently 100% of the 37 participants remain actively engaged. Due to COVID-19, Social Service Coordinators began communicating with consumers phone & via virtual platforms. Social service linkages to community resources increased during the 3rd quarter, mainly through face to face contact as more services opened up for business. The program's goal to reach 107 new participants continues to face challenges due to the COVID-19 pandemic. Clients are successfully engaged in treatment for substance use & mental health disorders, as well as treatment for HIV, and are provided much needed support for housing & other social service needs.



#### PERMANENT SUPPORTIVE HOUSING (PSH)


The Department of BHDD has partnered with Partners for HOME (PFH) & the Atlanta Housing Authority (AHA) to provide permanent housing solutions to individuals & families experiencing homelessness, and in need of long-term supportive services.





We are currently in year two of the 5 year plan of supportive housing, 24 of the 550 units have been successfully obtained with 4 families and 20 individuals. In the third quarter of 2021, 2 clients moved into housing bringing the total number of clients housed in PSH to 24 clients. Fulton County provides "New Beginnings" boxes to each client that contains basic move-in essentials. To date, 100% of the clients have maintained housing.





#### **SUPPORTIVE HOUSING: ATLANTA HOUSING VOUCHERS**

The Department (BHDD) has partnered with Partners for HOME & the Atlanta Housing Authority to provide permanent housing solutions to individuals & families experiencing homelessness, and in need of long-term supportive services. In the third quarter of 2021, one client moved into housing bringing the number of clients housed to 83. The Supportive Housing team is providing services across 13 properties with 93% of clients maintaining housing stability.

#### **SCREENING & RE-ENTRY UNIT (SRU)**


The SRU provides early detection to identify mental health concerns with inmates in the Fulton County jails by administering the Correctional Mental Health Screening (CMHS) to 100% of eligible bookings.








#### **DUI COURT PROGRAM**

The Fulton County DUI Treatment Court is to enhance public safety & promote healthier lifestyles for repeat DUI offenders. There are six (6) required components to participate in the DUI Treatment Court:

- Cognitive Behavioral Therapy
- Completion of DDS DUI, Alcohol or Drug Risk Reduction Program
- Submission to random home visits
- Random drug testing
- Participation at compliance reviews
- Community support meetings such as AA/NA










### **POLICING ALTERNATIVES & DIVERSION INITIATIVES (PAD)**

In October 2020, a grant was awarded the **U.S. Department of Justice, Bureau of Justice Assistance** to expand Fulton County's efforts to identify, respond to, treat, and support those impacted by substance use disorders & reduce the impact on the criminal justice system. **Fulton DBHDD,** and its partners, will expand pre-arrest diversion, case management, & training for law enforcement to the City of Atlanta and two other jurisdictions using the Law Enforcement Assisted Diversion (LEAD) model; provide recovery support services including transitional or recovery housing through Fulton DBHDD and its local partners; and offer evidence-based treatment including medication-assisted treatment (MAT) through partner Grady Hospital. In the 3rd quarter, PAD was able to refer **16** diversion clients to substance use treatment service









#### OPIOIDS/SUBSTANCE USE - MEDICATION ASSISTED TREATMENT SERVICES





- The Department continues to provide resources for residents with substance use disorders through a contractual agreement with Grady Health Systems Behavioral Health Clinic.
- The collaboration with Grady's Medication Assisted Outpatient program has provided services to 50 Fulton County residents with opioid use disorders from July 1, 2021 -September 30, 2021, for a total of 103 for the last nine months.
- Of the **50** clients seen, **12** received verbal interventions within the hospital.
- There were **20** clients that received induction doses of buprenorphine & **18** new residents seen in the outpatient clinic for follow up, either walk-ins or follow up from the




## DEVELOPMENTAL DISABILITIES Services Offered:

#### PROGRAMS & SERVICES

- The Fulton County Department of Behavioral Health and Developmental Disabilities (BHDD) provides outpatient day services programs to adults with intellectual and developmental disabilities (IDD), and is currently operating three programs in two locations: Central Training Center & North Training Center. South Training Center staff & individuals have been temporarily relocated to Central Training Center due to ongoing safety concerns at the facility.
- The emphasis of the IDD programs is to offer individualized services in the least restrictive environment & integrate those individuals into the community.



#### **CURRENT ACTIVITIES**

The IDD training centers successfully reopened for in-person services in June on a modified two or three day schedule and continued to offer the option of virtual services. From July 1 - September 30th, 548 telehealth/virtual sessions & 1,234 wellness calls have been completed with the IDD individuals. There were 814 face to face interactions through the 2nd quarter. Efforts towards the research and utilization of innovative service delivery approaches are an ongoing focus within the IDD population.



#### <u>Programs & Services</u>

- BHDD provides child, adolescent, & emerging adult services from 3 locations: Adamsville Regional Health Center, Oak Hill Child, Adolescent & Family Center, & North Fulton Service Center
- Services were provided mainly through use of telehealth networks from January 1 - September 30, 2021 serving 939 individuals with a total 11,583 client visits.
- A phased reopening plan was introduced in May for in-person services for clients who prefer that option & telehealth services are still offered
- Through September 30, 2021, 11,583 service contacts have been executed either by face to face 1,987 and/or telehealth/telephonic means 9,626.

### **JUSTICE PROGRAMS: RE-ENTRY TEAMS**

- BHDD has implemented a Re-Entry program within Fulton County jail with the placement
- of our adult team at the Union City location. Re-Entry is a voluntary community-based program offering case management support services for individuals incarcerated within Fulton County jails.
- Individuals with behavioral health needs, including substance use disorders, mental illness, trauma histories, & extensive involvement in the criminal justice system are in the priority focus group for the program.
- Re-Entry participants receive a continuum of care for up to one year after release to support positive choices, constructive behavior & accountability, thereby minimizing chances to reoffend
- In the third quarter of 2021, 27 new clients agreed to enroll in the Re-Entry program. The emerging adult team is currently providing services for 64 clients, 28 incarcerated clients and 36 released clients.

#### **KEY MEASURES**

- Reduce the number of people with mental illness booked into jail
- Shorten the average length of stay for those with mental illness in jail
- Increase the percentage of connection to care for individuals with mental illness upon release from jail
- Lower rates of recidivism for individuals with mental illness
- Coordinate reentry services to track & monitor the validated jail mental health screen & reentry assessment tools along with discharge planning
- Connect reentry services at the Fulton County Public Defender's Office with Fulton County Jail staff to increase the discharge planning capacity at the jail.










#### SUBSTANCE USE & SCHOOL-BASED PROGRAMS

#### THE RECOVERY SUPPORT CLUBHOUSE FOR YOUTH

- The Recovery Support Clubhouse for Youth offers services to adolescents between 14 & 17 during nontraditional hours to provide exposure to alternative choices to encourage drug free activities, education & life skills building. The program served 20 adolescents during the third quarter.
- The Clubhouse reopened for in person services at the end of the first quarter with the goal to increase engagement with the participants, their families and the staff. The staff maintains regular contact with the participants via telephone, in person visits and utilizing telehealth options. From July 1st September 30th, the staff completed 160 face to face sessions with the participants and their families, including individual counseling, group counseling, wellness checks, parent education, case management, community engagement activities, tutoring, nutrition classes and care package delivery drive-ups for the families.





#### TEXT 4 HELP



- Text 4 Help allows students to connect anonymously through text messages to licensed mental health professionals for resources & referrals 24 hours a day/7 days per week.
- From July 1st September 30, 2021, there have been 33 text messages delivered to the clinicians on call, with all texts receiving responses back under three minutes.
- As a part of CHRIS 180's contract with BHDD, the Department continues to fund the agency for licensed clinicians to respond 24/7 to all text messages received. With the upgrade to LEAD's system, the clinicians are now able to use an app that relays all text messages that students send. During this quarter, the majority of students texting reported either needing to talk with someone or having feelings of depression. The number of conversations initiated to clinicians has increased compared to the same time last year where only 18 messages were received.

  Number of Uninsured Clients: 210 between the partnering organizations. Summer services were provided via telehealth, in person in the community, and/or in person at the provider site closest to the students and families.
