WHEREAS, Fulton County ("County") entered into a Contract with **T&T Uniforms, Inc.** to provide Duty Gear and Uniforms, dated October 4, 2023, on behalf of the **Fulton County Marshal's Department**; and

WHEREAS the purpose of this amendment is to increase spending authority to procure Marshal badges and ballistic vests (100% grant funded) and to procure vest carriers (general funds).

WHEREAS, the Contractor has performed satisfactorily over the period of the contract; and

WHEREAS, the this amendment was approved by the Fulton County Board of Commissioners on **June 5, 2024, BOC Number 24-0387**

NOW, THEREFORE, the County and the Contractor agree as follows:

This Amendment No. 1 to Form of Contract is effective as of the 5th day of Jun, 2024, between the County and T&T Uniforms, Inc, who agree to provide Duty Gear and Uniforms in accordance with this Amendment No. 1 to Form of Contract and the Contract Documents.

1. **SCOPE OF WORK TO BE PERFORMED:** To provide Marshal badges, ballistic vests and vest carriers to the Fulton County Marshal's Department.
2. **COMPENSATION:** The commodities described under Scope of Work herein shall be provided by Contractor for the total amount not to exceed \$29,070.60.


