SUBJECT: Recommendation Award – ITB #25ITB1393177C-JNJ.

Testing and Repair of Backflow Devices-FY2026

Recommendation: We are recommending approval of the lowest bidder for, ITB #25ITB1393177C-JNJ Testing and Repair of Backflow Devices - FY2026 in the amount of \$200,000 with Maxair Mechanical LLC (Marietta, GA), to provide on-site testing and repair of approximately 183 backflow preventive (BFP) devices for required maintenance on an "asneeded" basis for the Fulton County facilities. Effective dates: January 1, 2026 through December 31, 2026, with two renewal options.

DISCUSSION: The recommendation for the award was based on the bidders' prices for testing for approximately 183 total devices and per hourly labor charges for repairing backflow devices to determine the lowest bidder for each of the three (3) geographical zones (Central, North, and South) in Fulton County facilities; and totaling up all costs for all three zones and per hour labor charge for Based Bid Amount to determine the lowest responsible bidder(s) complying with the provisions of this ITB.

The recommendation was also be based on the bidder's submittal of required valid Master II Plumber's License issued by the State of Georgia. Additionally, the licensed plumber shall have taken and completed a course of study in the repair of backflow preventers for repair of BFPs.

Recommendation:

The County received and evaluated two (2) bid responses to the solicitation. Maxair Mechanical, LLC submitted the lowest responsible and responsive bid in the amount of \$13,575.00. B & W Mechanical Contractors, Inc. submitted the 2nd lowest responsible and responsive bid in the amount of \$21,075.00. Therefore, we recommend Maxair Mechanical, LLC the award to provide on-site testing and repair of approximately 183 backflow preventive (BFP) devices for required maintenance on an "as-needed" basis for Fulton County facilities for Fulton County for FY2026.
