Request approval of change order less than 10% - Department of Real Estate and Asset Management, Bid# 16ITB102576K-JAJ, Modifications of Victim Assistance Department Suite in the amount of \$5,500 with Brad Construction Company II (Fayetteville, GA) to provide additional changes to the Victim Assistance Department suite located on the second floor of the Fulton County Courthouse. Effective upon BOC approval.

### **Summary & Background**

**Scope of Work:** These additional changes consist of: furnishing and installing caulk and silicone at the top of all wood base (600 feet); furnishing and installing quarter round trim at all wood base in common areas, kitchen, reception area and conference room (350 feet); furnishing and installing paint at windows sills at nine (9) locations; furnishing and installing additional thermostats devices in order to adequately accommodate the space; and furnishing and installing sheetrock repair at the new locations.

**Community Impact:** Awareness will increase regarding resources for victims of crime. This will be a secure, safe place for victims especially in family violence cases involving simple battery, simple assault, cruelty to children and stalking and those crimes related to public safety such a vehicular homicide and Driving Under the Influence. With this space, Victim Advocates in the Solicitor General's Office will be able to better serve victims in Fulton County including those victims in underserved communities who may have economic disadvantages, age or mental health challenges, language barriers or cultural issues.

areas, kitchen, reception area and conference room (350 feet); furnishing and installing paint at windows sills at nine (9) locations; furnishing and installing additional thermostats devices in order to adequately accommodate the space; and furnishing and installing sheetrock repair at the new locations at the Solicitor General's Victim Assistance Department suite located on the second floor of the Fulton County Court House 160 Pryor Street Atlanta, GA 30303.

This was a result of design changes that was related to unforeseen conditions by the contractors during the construction renovation.

The BOC approved contract #16ITB102576K-JAJ Modifications of Victim Assistance Department Suite in the amount of \$507,680.50 with Brad Construction Company II (Fayetteville, GA) to provide interior renovation services on July 20, 2016, as BOC Item #16-0605. The BOC also approved change order No. 1 less than 10% on February 1, 2017, as Item #17-0120 installed fire caulking at wall penetrations between project area and common hallway corridor.

**Project Implications:** To improve the necessary require changes to the existing scope that set forth in this construction renovation to accommodate the Victim Assistance Department. Providing this space for victim services will confirm that Fulton County is concerned about the safety of its citizens and that victims' lives matter regardless of their race, religion, sex or economic status. Victims will have more support as they seek justice in the criminal justice system.

**Community Issues/Concerns:** Coordinating our efforts with the community, victims will learn that this will be a safe place to discuss safe planning, warrant applications, victim's compensation, and referrals to shelters, government programs or non-profit agencies.
