

1   **RESOLUTION AUTHORIZING THE FULTON COUNTY TAX COMMISSIONER**  
2       **TO PROVIDE PAYMENT OF ANY AND ALL PROCESSING FEES**  
3   **ASSOCIATED WITH ELECTRONIC PAYMENTS REMITTED BY TAXPAYERS**

5       **WHEREAS**, the Georgia Department of Revenue and the Fulton County  
6 Tax Commissioner have partnered to enable taxpayers to pay motor vehicle  
7 taxes and fees electronically;

8       **WHEREAS**, the Georgia Department of Revenue provides the opportunity  
9 for the Fulton County Tax Commissioner to collect from tax payers or pay the  
10 processing fees; and

11       **WHEREAS**, the Fulton County Tax Commissioner collects and processes  
12 property taxes and other fees for Fulton County and other taxing authorities; and

13       **WHEREAS**, the Fulton County Tax Commissioner collects and processes  
14 property taxes and other fees electronically wherein the tax payer is charged  
15 processing fees; and

16       **WHEREAS**, the Board of Commissioners finds that the public interest will  
17 be served by authorizing and allowing any and all processing fees associated  
18 with tax payer remissions to be paid from the Fulton County commissions  
19 retained by the Tax Commissioner prior to distribution to Fulton County.

20       **NOW THEREFORE, BE IT RESOLVED**, that the processing fees charged  
21 by Fulton County for processing fees associated with electronic payments  
22 received by the Fulton County Tax Commissioner shall be waived (or eliminated);  
23 and

24       **BE IT FURTHER RESOLVED**, that the Fulton County Tax Commissioner  
25 is directed to prepare, or cause to be prepared, any and all specific changes to

1 the tax receipt and payment collection system(s) that are necessary and proper  
2 in order to effectuate the intent of this Resolution.

3 **BE IT FURTHER RESOLVED**, that this Resolution shall become effective  
4 after July 1, 2020, and that all resolutions and parts of resolutions in conflict with  
5 this Resolution are hereby repealed to the extent of the conflict.
