A RESOLUTION APPROVING A LEASE AGREEMENT BETWEEN FULTON COUNTY. 1 GEORGIA (LANDLORD) AND THE BOARD OF REGENTS OF THE UNIVERSITY 2 SYSTEM OF GEORGIA (TENANT) FOR THE PURPOSE OF PROVIDING LIBRARY 3 SERVICES AT CENTRAL LIBRARY TO THE VISUALLY IMPAIRED AND 4 PHYSICALLY HANDICAPPED PATRONS; AUTHORIZING THE CHAIRMAN TO 5 EXECUTE THE LEASE AGREEMENT; AUTHORIZING THE COUNTY ATTORNEY TO 6 APPROVE THE LEASE AGREEMENT AS TO FORM AND MAKE ALL NECESSARY 7 MODIFICATIONS THERETO PRIOR TO EXECUTION; AND FOR OTHER PURPOSES. 8

WHEREAS, Fulton County, Georgia , ("Fulton County") is a political subdivision of
the State of Georgia, existing as such under and by the Constitution, statutes, and laws
of the State of Georgia; and

WHEREAS, the General Assembly of Georgia proposed an amendment to the Constitution of Georgia in 1982 (Georgia Laws 1982, page 4174 as amended by Georgia Laws 2004, page 4347), authorizing the General Assembly to provide for the creation of a county-wide public library system in any county having a population of 550,000 or more according to the 1980 Census or any future census, which amendment was ratified by the electors in the General Election of 1982; and

WHEREAS, the Fulton County Library System is composed of the Central Library and the Auburn Avenue Research Library, with thirty-three (33) branch libraries within the geographical limits of Fulton County Georgia; and

WHEREAS, the Fulton County Library System is engaged in a \$275 million capital
improvement program that is funded by a library bond referendum approved by Fulton
County voters in 2008; and

WHEREAS, it is the desire of Fulton County and the Board of Regents of the University System of Georgia, a constitutional body of the State of Georgia, to enter into a lease agreement for the purpose of formalizing lease agreement terms for 3,161 square feet of office space being utilized at 1 Margaret Mitchell Square NW, Atlanta, Georgia 30303 (the "Central Branch Library") to provide library services for the visually-impaired and physically handicapped patrons of the Fulton County Library System; and

WHEREAS, O.C.G.A. § 36-10-1 provides that all contracts entered into by the Board of Commissioners shall be in writing and entered on it minutes.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners hereby approves the Lease Agreement with the Board of Regents of the University System of Georgia to formalize the rental terms of the Lease Agreement, in substantially the form attached hereto as Exhibit "A." 1 **BE IT FURTHER RESOLVED,** that the Chairman of the Board of Commissioners is 2 hereby authorized to execute the Lease Agreement between Fulton County and the 3 Board of Regents of the University System of Georgia after approval as to form by the 4 County Attorney.

5 **BE IT FURTHER RESOLVED,** that this Resolution shall become effective upon its 6 adoption, and that all resolutions and parts of resolutions in conflict with this Resolution 7 are hereby repealed to the extent of the conflict.
