



Benchmark Counties





COUNTYWIDE DASHBOARDS

OBJECTIVE 1: Business Development



There has been a substantial increase in the total number of private businesses in Fulton County over the past ten years, growing nearly 20% over that time period. Fulton County ranked first among its national benchmark counties in the number of private businesses as of the third quarter of 2016.



The consumer price index for Atlanta metro area has increased on average just under 1% every six months for the past 5 years. This rate places the Atlanta area ahead of the average for class A metro areas (population over 1.5 million) in all regions except the West.

OBJECTIVE 1: Business Development




The value of commercial and industrial buildings and land in the county as a proportion of all real property value has hovered around 40% for the past sixteen year, beginning the period at a high of 43.5%, dipping to a low of 36.1% in 2007 and rising gradually to a 2016 value of 40.7%.




The number of new housing units permitted in Fulton County fell dramatically during the recession and has yet to fully rebound to prerecession levels. The quarterly number of units permitted has been highly seasonal over the past three years, generally peaking in spring. The second quarter of 2016 saw a nine year high of 3,664 units permitted. Fulton County ranked second among its national benchmark counties.

OBJECTIVE 2: Employment



The employment rate remained fairly steady through 2016 after showing a slow upward trend that began in 2009. The March 2017 employment rate for the County of 95.1% is just above what is generally considered the full employment rate of 95%.




The employment rate among young male adult residents has seen steady and significant growth (+3.5%) since 2012. Compared to national benchmark counties, Fulton County has the 3rd lowest employment rate among young male adults. The nationwide employment rate of male adult age 20 to 34 is 89.7%.

OBJECTIVE 2: Employment




The Gini index for Fulton County was 0.54 in 2015, higher than that for the U.S., Georgia and the Atlanta metro area, all of which have an index of around 0.48. A higher Gini index indicates ae greater inequality in income distribution. Fulton also has the greatest income inequality among its national benchmark counties.



The median household income rose steadily from \$55,369 in 2012 to \$60,291 in 2015. Among its national benchmark counties, Fulton County ranks fourth in terms of median household income. The median household income for the U.S. was \$55,775 in 2015.


OBJECTIVE 3: Business Climate Perception

The **Business Climate Satisfaction Rate** performance measure is based on a survey currently being conducted by Kennesaw State University. Results will be delivered to the County as soon as the minimum number of survey responses from the business community are received and tabulated.



Spending on roadway infrastructure by all Fulton County and its local jurisdictions remained fairly constant over the past few years with a slight increase in 2015. The largest expenditures were made by Atlanta (35%), Sandy Springs (17%) and Johns Creek (13%). Fulton's contribution toward the overall expenditures was about 4%.


OBJECTIVE 3: Business Climate Perception




The total number of people employed by private business in Fulton County has generally followed a steadily increasing trend since 2009. As of September 2016, the total number employed in private industries in Fulton County has reached a fifteen year high of 733 thousand people. As of September 2016, Fulton ranked second only to Hennepin County, MN (Minneapolis) in the number of people employed by private industry.

Gigabit Internet Availability by businesses is currently being researched.

OBJECTIVE 4: Workforce Readiness




The percent of Fulton County residents with high school diploma and equivalent has remained just above 90%, increasing slightly from 90.3% in 2012 to 91.7% in 2015. Fulton County ranks fourth highest in this area among its national benchmark counties.




Fulton County has the third highest percentage of college-educated residents among its national benchmark counties -- 55.4% of the residents in Fulton County have 2-year college degrees or higher. Fulton County has the highest percentage (20.2%) of residents with graduate or professional degrees among its benchmark counties.

OBJECTIVE 4: Workforce Readiness



The percentage of high school graduates who have demonstrated readiness for post high school education (defined by Georgia Department of Education) has remained fairly steady, ranging between 72% and 77% over the past few years. Overall, high school graduates from Fulton County school systems rank just above the state average; however, the percentage of students demonstrating post-high school readiness varies widely by high school, ranging from 26.8% for Douglass High School to 100% for four schools in north Fulton.



There has been a substantial trend upward in the high school graduation rate over the last three years. The dramatic increase in the graduation rate reflected in 2014 is likely attributable to the fact that the state of Georgia changed the testing requirements for graduation during that period. Among individual high schools, the 2016 graduation rate ranged from 66.8% for Therrell High School to 97.4% for Milton High School.













