**W I T N E S S E T H**

WHEREAS, Fulton County ("County") entered into a Contract with Transdev Services, Inc. to provide senior transportation services, dated 1st of January 2017, on behalf of the Department of Senior Services; and

WHEREAS, the County wishes to extend the contract for an additional three (3) months as the Department of Senior Services completes cost proposal negotiations, and to include a new rate change within the monthly invoicing to reflect a fixed cost line item; and

WHEREAS, Extension No. 1 was approved by the Fulton County Board of Commissioners on October 6, 2021, BOC#21-0775; and

WHEREAS, the Contractor has performed satisfactorily over the period of the contract; and

WHEREAS, Extension No. 2 was approved by the Fulton County Board of Commissioners on BOC 03/16/2022, Item#22-0196.

**NOW, THEREFORE**, the County and the Contractor agree as follows:

This Extension No. 2 to Form of Contract is effective as of the 1st day of April, 2022, between the County and Transdev Services, Inc., who agree that all Services specified will be performed in accordance with this Extension No. 2 to Form of Contract and the Contract Documents for an additional three (3) month period, with the contract ending June 30, 2022.

1. **SCOPE OF WORK:** To provide senior transportation services for an additional three (3) month period through June 30, 2022 and to include a new rate change

within the monthly invoicing to reflect a fixed cost line item of \$15,139.00 for wage increases.

2. **COMPENSATION:** The Services herein shall be performed by the Contractor for a total amount not to exceed \$1,350,000.00 (One Million Three Hundred Fifty Thousand Dollars and No Cents).
3. **LIABILITY OF COUNTY:** This Extension No. 2 to Form of Contract shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the Chair to the Commission, attested to by the Clerk to the Commission and delivered to Contractor.
4. **EFFECT OF EXTENSION NO. 2 TO FORM OF CONTRACT:** Except as modified by this Extension No. 2 to Form of Contract, the Contract, and all Contract Documents, remain in full force and effect.




