W I T N E S S E T H

WHEREAS, Fulton County ("County") entered into a Contract with **MTI Limo and Shuttle Services, Inc.** to provide Bus and Shuttle Services, dated 1st day of April 2025, on behalf of the **Department of Real Estate and Asset Management**; and

WHEREAS, the purpose for of this amendment is for the approving of increasing spending authority to cover the costs for additional annual expenses associated with an increase in bus and shuttle services supporting various initiatives and events sponsored by County agencies; and

WHEREAS, the Contractor has performed satisfactorily over the period of the contract; and

WHEREAS, this amendment was approved by the Fulton County Board of Commissioners on **September 17, 2025, BOC Item #25-0716**.

NOW, THEREFORE, the County and the Contractor agree as follows:

This Amendment No. 1 to Form of Contract is effective as of the 3rd day of September 2025, between the County and **MTI Limo and Shuttle Services, Inc.**, who agree that all Services specified will be performed in accordance with this Amendment No. 1 to Form of Contract and the Contract Documents.

1. **SCOPE OF WORK TO BE PERFORMED:** Providing additional bus and shuttle services in support of various County agencies requiring bus and shuttle services in support of multiple County initiatives including the Department of Community Development's transport of the destitute citizens to designated shelters during the 2025 winter season, and the District Attorney's Junior DA Summer Intern program.

Because of these additional bus and shuttle services, which will have an impact on the original approved spending authority of \$608,877.00 by end of this FY2025. This increase in spending authority will allow DREAM to cover remaining costs associated with bus and shuttle services for jurors and County staff through the end of FY2025.

2. **COMPENSATION:** The services described under Scope of Work herein shall be performed by Contractor for a total amount not to exceed **\$90,000.00** (Ninety Thousand Dollars and Zero Cents).
3. **LIABILITY OF COUNTY:** This Amendment No. 1 to Form of Contract shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the Chair to the Commission, attested to by the Clerk to the Commission and delivered to Contractor.
4. **EFFECT OF AMENDMENT NO. 1 TO FORM OF CONTRACT:** Except as modified by this Amendment No. 1 to Form of Contract, the Contract, and all Contract Documents, remain in full force and effect.

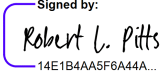
