**W I T N E S S E T H**

WHEREAS, Fulton County, Georgia (“County”), on behalf of its Department of Senior Services, entered into a Memorandum of Understanding (“MOU”) with Quality Living Services, Inc. (“QLS”) in the amount of \$50,000.00 to provide planning and coordination of services for the senior population of Fulton County at the Fulton County/QLS Center for Senior Citizens, dated November 17, 2021 (Agenda Item 21-0918), for a term commencing on January 1, 2022 through December 31, 2022, with five (5) automatic successive renewals; and

WHEREAS, on January 19, 2022, the Board of Commissioners allocated an additional \$100,000.00 in financial support to QLS as part of the FY2022 budget pursuant to Agenda Item 22-0050; and

WHEREAS, on May 4, 2022 pursuant to Agenda Item 22-0322, the Board of Commissioners approved an amendment to the MOU to provide this additional \$100,000.00 in financial support for the senior population of Fulton County at QLS; and

WHEREAS, the May 4, 2022, which was Amendment No. 1 to the MOU, was inadvertently officially designated as Amendment No. 2 to the MOU; and

WHEREAS, the MOU was automatically renewed on January 1, 2023 to run through December 31, 2023 (“1<sup>st</sup> Renewal”); and

WHEREAS, on January 18, 2023, the Board of Commissioners allocated an additional \$500,000.00 in financial support to QLS as part of the FY2022 budget pursuant to Agenda Item 23-0044; and

WHEREAS, on February 15, 2023 pursuant to Agenda Item 23-0131, the Board of Commissioners approved Amendment No. 3 to the MOU to provide this additional \$500,000.00 in financial support for Life Enrichment, Fitness and Congregate Dining services for the senior population of Fulton County at QLS; and

WHEREAS, the MOU was automatically renewed on January 1, 2024 to run through December 31, 2024 (2<sup>nd</sup> Renewal”); and

WHEREAS, on January 24, 2024, the Board of Commissioners allocated an additional \$100,000.00 (non-recurring) in financial support to QLS as part of the FY2024 budget pursuant to Agenda Item 24-0051; and

WHEREAS, the County is now amending the MOU to reflect this additional \$100,000.00 to supplement existing funding for QLS, with this approval being designated as Amendment No. 4 to the MOU; and

WHEREAS, on January 21, 2026, the Board of Commissioners allocated an additional \$100,000.00 (non-recurring) in financial support to QLS as part of the FY2026 budget pursuant to Agenda Item 26-0032; and

WHEREAS, the County is now amending the MOU to reflect this additional \$100,000.00 to supplement existing funding for QLS, with this approval being designated as Amendment No. 5 to the MOU; and

WHEREAS, the County is now amending the MOU to reflect this additional \$100,000.00 to supplement existing funding for QLS, with this approval being designated as Amendment No. 6 to the MOU; and

WHEREAS, the County is also amending the MOU to capture the County’s responsibility of employing a qualified computer instructor; and

WHEREAS, the Contractor has performed satisfactorily over the period of the contract; and

WHEREAS, this amendment was approved by the Fulton County Board of Commissioners on [Insert Board of Commissioners approval date and item number].

**NOW, THEREFORE,** the County and the Contractor agree as follows:

This Amendment No. 6 to Form of Contract (MOU) is effective as of the \_\_\_ day of \_\_\_, 2026, between the County and QLS, who agree that all Services specified will be performed in accordance with this Amendment No. 6 to Form of Contract (MOU) and the Contract (MOU) Documents as set forth below.

1. **SCOPE OF WORK TO BE PERFORMED:** Planning and coordination of Life Enrichment, Fitness and Congregate Dining services for the senior population of Fulton County at the Fulton County/QLS Center for Senior Citizens. Quarterly progress reports will be provided in April, July, October and December 2026.

**Section B (County/DSS Responsibilities) of the original MOU, as amended, is further amended to add new sections (5) and (6), to read as follows:**

- (5) Employ a qualified computer instructor to provide ongoing computer classes at the QLS Senior Center or QLS residential facilities. Class topics shall include but not be limited to the following subject areas:
  - Introduction to Computers and Keyboarding
  - Introduction to Microsoft Applications:
    - Word, Excel, Power Point, and Publisher
  - Using the Internet
    - E-mail, Social Media, Zoom, etc.
  - Smart Phones
    - Iphone and Android
  - Cyber Security and AI (artificial intelligence)
- (6) The computer instructor is responsible for the following:
  - a. Develops and designs course curriculum
  - b. Manages course schedules
  - c. Manages and maintains computer lab
  - d. Provides supplies for the computer classes.
  - e. Serves 150 or more residents of Fulton County age 60 and above through the computer classes.
  - f. Maintains accurate records of expenditures and the disposition of funds in accordance with good accounting practices. Such records shall be made available

2. **COMPENSATION:** The services described under Scope of Work herein shall be performed by Contractor for a total amount not to exceed \$150,000.00. Compensation will be remitted in three payments; contractor is to submit invoices by 4/28/2026.
3. **LIABILITY OF COUNTY:** This Amendment No. 6 to Form of Contract (MOU) shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the Chair to the Commission, attested to by the Clerk to the Commission and delivered to Contractor.
4. **EFFECT OF AMENDMENT NO. 6 TO FORM OF CONTRACT (MOU):** Except as modified by this Amendment No. 6 to Form of Contract (MOU), the MOU, and all Contract (MOU) Documents, remain in full force and effect.
