


INCIDENT RESPONSE REVIEW

- Cases, hospitalizations, and % positives have plateaued for the last week, while the 7-day average for deaths has increased for 0.7 to 2.7
- Fulton County is currently experiencing dangerous hospital room shortages, with trauma centers and emergency rooms having to periodically go on diversion to allow for decompression
- While the tracked metrics are beginning to trend down, a post holiday bump is expected.
- 3 of 4 major indicators on the Fulton County scorecard are still red.

Incident Response Update (Heat Maps September 1 vs September 15)





Fig. 8. Incidence Rates by Fulton City for Recent 14-day Reporting Period



- **Fulton County COVID-19**

- 7-day average for cases is **349** down 8% since the last BoC mtg.
- 7-day average for % positive is **10.8** down 15% since the last BoC mtg.
- 7-day average, Hospitalizations is **643** down 9% since the last BoC mtg.
- 7 day average, for deaths is **2.6** up 265% since same last BoC mtg.



VACCINATION RESPONSE

- Fulton County fixed & mobile vaccination sites reached the 525K vaccines administered.
- Fulton County mobile vaccination units have administered over 38K doses of vaccines.
- Ten mobile units will be at 46 locations this week.
- Vaccinations will continue to be available at these fixed locations: 6 Board of Health Clinics, 141 Pryor St, 4700 North Point, and *5710 Stonewall Tell Rd. * Open till 8 PM
- BoH has 1 roving strike teams working in targeted areas providing vaccines and answering questions about hesitancy.
- Mobile units vaccinated 343 individuals (283 students & 60 faculty/staff) at 31 APS locations last week





Person engagement


- 229 interactions (58% vaccinated, 30% unvaccinated, 12% undisclosed)
- 9 assisted with appointment registrations
- Vaccine access barriers: Location of vax site (60%), Time off work (30%) and Language barrier (10%)
 - Time off work- Symptoms affecting return to work
- Reasons uninterested in vaccination: Don't believe in COVID-19 vaccine (85%), Side effects (10%), Religious beliefs (5%)
 - Side effects: Soreness at injection (50%), flu-like symptoms (25%), headache (25%)
- "It's not for me"
- "Won't get vaccine because it's not the cure"
- Fears expressed: size of needle, clinician won't take their fears seriously or won't be kind

Business engagement/advertisements

- Distributed fliers to 84 businesses

Vaccination Response: Delta Variant

United States: 8/29/2021 – 9/4/2021 NOWCAST



- Delta variant now accounts for 99% of new cases nationwide, 98% in GA (all Orange)
- Delta is more virulent, 5 to 10 times more than the Alpha Strain
- The symptoms are generally the same
- Early data suggests that Delta may have a higher hospitalization rate than Alpha
- Currently the death rate for Delta is similar to the Alpha
- The best defence for the delta variant is still mRNA Vaccines





Georgia Homeowner Assistance Fund

Background:

US Treasury Department allocated \$9.9 billion to states and territories through the American Rescue Plan Act of 2021. Georgia's allocation was \$354M. The Department of Community Affairs (DCA) will administer the **State of Georgia Homeowner Assistance Fund**.

Key Points

State of Georgia Homeowner Assistance Fund

- The Homeowner Assistance Fund (HAF) program was established to mitigate financial hardships associated with the coronavirus pandemic by providing funds for the purpose of preventing homeowner mortgage delinquencies, defaults, foreclosures, loss of utilities, and displacements of homeowners experiencing financial hardship after **January 21, 2020**.
- DCA will create an online application for individuals to apply to receive funding.
- Georgia's plan is due to Treasury by July 31, 2021. The program will be launched after approved by Treasury.

State of Georgia Division Director for Housing

- Georgia submitted its Homeowners Assistance Fund Plan (HAF Plan) for Treasury approval in mid-August and they are still waiting to hear back.
- So far, Treasury has not approved any HAF Plan submissions from the states, but Georgia is hopeful this will happen soon.
- In the interim, **DCA has established a pilot program that allows us to receive applications and fund homeowner needs for certain loans in our existing portfolio of GA Dream loans.**

Since the beginning of COVID-19, the Fulton County Court System has amassed a significant and unprecedented level of cases. Project ORCA will address this challenge by utilizing a combination of capacity expansion and productivity enhancement initiatives to expedite the case adjudication process.

Case Accumulation Defined



SPACE REQUIREMENTS

The plan encompasses a multi-year period for case processing and related facility support to provide courtrooms, adaptive spaces to serve as temporary courtrooms and office space for additional staff. The plan anticipates making use of existing Fulton County Court resources and spaces, while considering and evaluating what other resources may be required.

The project has been broken into three phases, all starting concurrently but with different lead times for completion.


TECHNOLOGY

- ✓ 100 remote workstations have been deployed to offices
 - each workstation includes a laptop, monitor, docking station, keyboard, mouse and laptop bag
- ✓ The remaining 138 workstations will be deployed before September 30, 2021

The Courts have continued to proceed with adjudication using the following techniques:

- ✓ Leveraging ZOOM technology options to hold virtual hearings and reduce exposure to court staff and inmates
- ✓ Performing virtual jury selection to save time and reduce exposure
- ✓ Using more effective case triage methods to separate calendar participants and route cases for quicker resolution
- ✓ Offering electronic transmission of documents wherever possible to save time and resources
