A RESOLUTION BY FINANCE/EXECUTIVE COMMITTEE AUTHORIZING THE MAYOR OR HIS DESIGNEE, TO EXERCISE THE SECOND RENEWAL OPTION FOR SPS/DAIM/2210-1230127, COVENDIS ON-CALL IT SERVICES WITH UWORK.COM, INC., DBA COVENDIS TECHNOLOGIES, INC., ON BEHALF OF THE DEPARTMENT OF ATLANTA INFORMATION MANAGEMENT, FOR A TERM OF ONE (1) YEAR, EFFECTIVE FROM AUGUST 12, 2024 THROUGH AUGUST 11, 2025, IN AN AMOUNT NOT TO EXCEED SEVEN MILLION ONE HUNDRED SIXTY-THREE THOUSAND TWO HUNDRED THREE DOLLARS AND SIXTY CENTS (\$7,163,203.60); ALL CONTRACTED WORK WILL BE CHARGED TO AND PAID FROM THE FUND DEPARTMENT ORGANIZATION AND ACCOUNT NUMBER LISTED HEREIN; AND FOR OTHER PURPOSES.

WHEREAS, pursuant to Ordinance No. 22-O-1830, the City of Atlanta (“City”) entered into Special Procurement Agreement SPS/DAIM/2210-1230127, Covendis On-Call IT Service (“Agreement”) with uWork.com Inc. dba Covendis Technologies, Inc. (“Covendis”), on behalf of the Department of Atlanta Information Management, in an amount not to exceed Three Million Nine Hundred Twenty-Three Thousand Dollars and Zero Cents (\$3,923,000.00); and

WHEREAS, the Term of the Agreement was one (1) year, effective August 12, 2022 to August 11, 2023, and two (2) one-year renewal options; and

WHEREAS, pursuant to Resolution 23-R-3302, adopted by the Atlanta City Council on March 20, 2023 and approved per City Charter Section 2-2403 on March 29, 2023, the City executed the first amendment to the Agreement, to add funding including ARPA funds in an amount not to exceed Two Million Nine Hundred Thirty-Six Thousand Dollars and Zero Cents (\$2,936,000.00); and

WHEREAS, pursuant to Resolution 23-R-3655, adopted by the Atlanta City Council on June 5, 2023 and approved per City Charter Section 2-2403 on June 14, 2023, the City exercised the first renewal option of the Agreement for a term of one (1) year, effective August 12, 2023 through August 11, 2024, in an amount not to exceed Four Million Eight Hundred Thirty-Five Thousand Six Hundred Dollars and Zero Cents (\$4,835,600.00), with one renewal option remaining; and

WHEREAS, pursuant to Resolution 23-R-4593, adopted by the Atlanta City Council on December 4, 2023 and approved per City Charter Section 2-2403 on December 13, 2023, the City executed the second amendment to the Agreement, to include cost volume discounts, to add the Department of Finance, the Mayor’s Office, and the Department of Parks and Recreation as authorized users, and to add additional funding in an amount not to exceed One Million Five Hundred Seventy Thousand Dollars and Zero Cents (\$1,570,000.00); and

WHEREAS, the first renewal term will expire on August 11, 2024; and



WHEREAS, Covendis continues to satisfactorily perform under the Agreement; and

WHEREAS, the Chief Information Officer of the Department of Atlanta Information

Management and the Chief Procurement Officer recommend exercising the second renewal option under the Agreement, on behalf of the Department of Atlanta Information Management, for a term of one (1) year, effective August 12, 2024 through August 11, 2025, in an amount not to exceed Seven Million One Hundred Sixty-Three Thousand Two Hundred Three Dollars and Sixty Cents (\$7,163,203.60); and

WHEREAS, the Chief Procurement Officer certifies that any organizational and personal relationships disclosed by Covendis have been considered in accordance with Section 2-1214 of the City of Atlanta Code of Ordinances and renewal of the Agreement is appropriate.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor, or his designee, is authorized to exercise the second renewal option under SPS/DAIM/2210-1230127, Covendis On-Call IT Service with Covendis, on behalf of the Department of Atlanta Information Management, in an amount not to exceed Seven Million One Hundred Sixty-Three Thousand Two Hundred Three Dollars and Sixty Cents (\$7,163,203.60).

BE IT FURTHER RESOLVED, that the Term of the second renewal option is one (1) year year(s), effective August 12, 2024 through August 11, 2025 and there are zero (0) renewal options remaining under the Agreement.

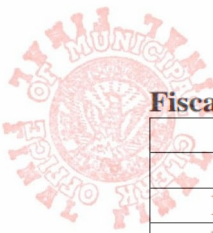
