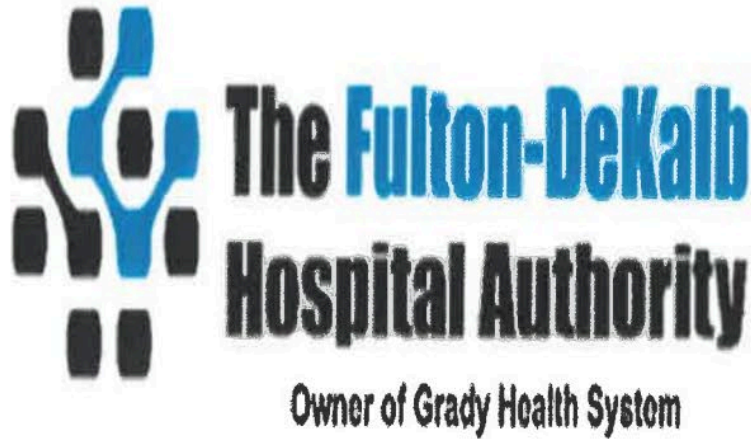

- Conducted an organizational restructuring and realignment
- Replaced and retooled critical roles and functions

- Concluded a strategic planning process that included key informant interviews and community stakeholder input
- Supported the planning and launch of Grady's Office of Health Equity Diversity and Inclusion (HEIDI)
- Defined organizational priorities consistent with the existing and emergent needs of the counties
- Launched a comprehensive forensic audit to identify opportunities to strengthen internal management systems
