Fulton County development regulations require that all new sewer connections acknowledge Fulton County's ownership interests in the area(s) in which a connection is being made to the County's sewer system prior to the issuance of a Land Disturbance Permit. The easement area to be conveyed consists of 14,732 square feet and is located in Land Lots 332 and 352 of the 1st District, 2nd Section of Fulton County, Georgia.

Community Impact: The community will benefit from the extension of the County's sewer system and the addition of a new educational development.

Department Recommendation: The Department of Real Estate and Asset Management recommends acceptance of the easement dedication.

WITNESSETH, that for and in consideration of \$1.00 in hand paid, at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged and in consideration of the benefits which will accrue to the undersigned from the construction of a sewer line through subject property, and in consideration of the benefits which will accrue to the subject property from the construction of a sewer line through subject property, said Grantor has granted, bargained, sold and conveyed and by these presents does grant, bargain, sell and convey to FULTON COUNTY and to its successors and assigns the right, title, and privilege of easements through subject property located in Land Lot(s) 332 & 352, 2nd Section of the 1st District, Fulton County, Georgia (hereinafter called the "Property"). Said easement is shown on Exhibit "A" (hereinafter called the "Easement Area"). To wit:

For the same consideration, Grantor hereby conveys and relinquishes to Grantee a right of access over Grantor's remaining lands as necessary for Grantee to perform maintenance and repairs on said sewer line on both a routine and emergency basis.

Grantor acknowledges it is the owner of the Property and has approved the conveyance of this Easement by public vote as required by law. Said Grantor hereby waives for itself, its successors and assigns all rights to any further compensation on account of the construction, access, upgrade or maintenance of said sewer line or for the use of the Property as herein agreed. Except for the rights, privileges, benefits and easement granted herein, Grantor reserves unto itself all rights ownership, title, use and enjoyment of the Easement Area and the Property not inconsistent herewith.


