WHEREAS, Fulton County ("County") entered into a Contract with Aramark Correctional Services, LLC to provide/perform food services and related food service operation, dated November 1, 2017, on behalf of the Fulton County Sheriff's Office; and

WHEREAS, the County wishes to extend the subject contract, with all terms and conditions unchanged, for an additional eight month period; and

WHEREAS, the Contractor has performed satisfactorily over the period of the contract; and

WHEREAS, this Extension was approved by the Fulton County Board of Commissioners on April 20, 2022, BOC# 22-0292.

NOW, THEREFORE, the County and the Contractor agree as follows:

This Extension No. 2 to Form of Contract is effective as of the 1st day of May 2022, between the County and Aramark Correctional Services, LLC who agree that all Services specified will be performed by in accordance with this Extension No. 2 to Form of Contract and the Contract Documents for an additional eight month period, with the contract ending as of 31st day of December, 2022.

1. **COMPENSATION:** The services herein shall be performed by Contractor for a total amount not to exceed \$2,550,739.00 (Two Million, Seven Hundred Thirty-Nine Thousand Dollars and Zero Cents).
3. **LIABILITY OF COUNTY:** This Extension No. 2 to Form of Contract shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the Chair to the Commission, attested to by the Clerk to the Commission and delivered to Contractor.

4. **EFFECT OF EXTENSION NO. 2 TO FORM OF CONTRACT:** Except as modified by this Extension No. 2 to Form of Contract, the Contract, and all Contract Documents, remain in full force and effect.
