

RESOLUTION TO ABOLISH FUND 419, CLERK OF SUPERIOR AND MAGISTRATE COURT TECHNOLOGY FUND AND FUND 439 CLERK OF COURT TECHNOLOGY FUND AND REQUIRING ALL FUNDS WITHIN THESE FUNDS AND ALL FUTURE REVENUE PREVIOUSLY ASSOCIATED WITH THESE FUNDS TO BE DEPOSITED INTO THE COUNTY GENERAL FUND; AND FOR OTHER PURPOSES.

WHEREAS, Fulton County Government has various funds referred to as Special Appropriation Funds and such funds are used to account for the proceeds of specific revenue sources such as specific taxes or fees (excluding major capital projects that are legally restricted to expenditures for specified purposes); and

WHEREAS, Fund 419, Clerk of Superior and Magistrate Court Technology Fund is a Special Appropriation Fund which holds funds generated through E-Recording fees and used for technology in the Clerk of Superior and Magistrate Court; and

WHEREAS, Fund 439, Fulton Clerk of Courts Technology Fund holds funds which are generated through E-file fees and is used for technology in the Clerks to Superior and Magistrate Court and State Court; and

WHEREAS, the Fulton County Board of Commissioners deems Fund 419, Clerk of Superior and Magistrate Court Technology Fund and Fund 439, Fulton Clerk of Courts Technology Fund to no longer be an appropriate and effective approach to funding, budgeting and planning of technology spending and expenditures; and

WHEREAS, the Fulton County Board of Commissioners desires to abolish Fund 419, Fulton Clerk of Courts Technology Fund and Fund 439, Fulton Clerk of Courts Technology Fund and require all fees and other revenue currently being deposited into Fund 419 and Fund 439 to be deposited into the County General Fund upon adoption of this resolution and require all fund balances associated with Fund 419 and Fund 439 to be deposited into the County General Fund; and

1 BE IT FINALLY RESOLVED, that this Resolution shall become effective upon its
2 adoption, and that all resolutions and parts of resolutions in conflict with this Resolution
3 are hereby repealed to the extent of the conflict.
