WHEREAS, Fulton County ("County") entered into a Memorandum of Understanding with Quality Living Services, Inc. (QLS) in the amount of \$50,000.00 to provide planning and coordination of services for the senior population of Fulton County at the Fulton County/QLS Center for Senior Citizens, dated November 17, 2021, on behalf of the Department of Senior Services; and

WHEREAS, the County is amending the MOU for an additional \$500,000 (nonrecurring) to supplement existing funding for the Quality of Living Services (QLS) pursuant to agenda item 23-0044 approved by the Board of Commissioners on January 18, 2023; and

WHEREAS, the Contractor has performed satisfactorily over the period of the contract; and

WHEREAS, this amendment was approved by the Fulton County Board of Commissioners on [Insert Board of Commissioners approval date and item number].

NOW, THEREFORE, the County and the Contractor agree as follows:

This Amendment No. 3 to Form of Contract is effective as of the ____ day of _____, 20__, between the County and QLS, who agree that all Services specified will be performed in accordance with this Amendment No. 3 to Form of Contract and the Contract Documents.

1. **SCOPE OF WORK TO BE PERFORMED:** Planning and coordination of Life Enrichment, Fitness and Congregate Dining services for the senior population of

Fulton County at the Fulton County/QLS Center for Senior Citizens. Quarterly progress reports will be provided in April, July, October 2023 and January 2024.

2. **COMPENSATION:** The services described under Scope of Work herein shall be performed by Contractor for a total amount not to exceed \$500,00.00. Compensation will be remitted in three payments; contractor is to submit invoices by the following dates: 2/28/2023; 3/31/2023; and 4/28/2023.
3. **LIABILITY OF COUNTY:** This Amendment No. 3 to Form of Contract shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the Chair to the Commission, attested to by the Clerk to the Commission and delivered to Contractor.
4. **EFFECT OF AMENDMENT NO. 3 TO FORM OF CONTRACT:** Except as modified by this Amendment No. 3 to Form of Contract, the Contract, and all Contract Documents, remain in full force and effect.
