- current lease agreement with LIT/ HODGES Industrial Trust for 24,798 square feet of
- warehouse and office space at the Board of Commissioner's Meeting held June 19, 2013
- 18 as Agenda Item 13-0406; and
- 19 WHEREAS, the current lease agreement was for a period (10) ten years and
- 20 included certain renewal options; and
- 21 **WHEREAS**, the Initial Term of the current lease agreement will expire December
- 22 31, 2023; and
- 23 **WHEREAS**, at the request of the Office of the Fulton County District Attorney the
- Department of Real Estate and Asset Management has negotiated mutually acceptable
- rental terms to extend the current lease for a period of (7) years, inclusive of renewal
- 26 terms; and
- WHEREAS, the Office of the Fulton County District Attorney and the Department
- of Real Estate and Asset Management requests the approval of the Board of

10	is hereby authorized to execute the First Amendment and Extension to Lease Agreement
11	between Fulton County and LIT/ HODGES Industrial Trust.
12	BE IT FURTHER RESOLVED, that the County Attorney is hereby authorized to
13	approve the First Amendment and Extension to Lease Agreement as to form and to make
14	such modifications as are necessary to protect the County's interests prior to execution
15	by the Chairman.
16	BE IT FURTHER RESOLVE, that this Resolution shall become effective upon its
17	adoption, and that all resolutions and parts of resolutions in conflict with this Resolution
18	are hereby repealed to the extent of the conflict.
