WHEREAS, Fulton County ("County") entered into a Contract with **Piedmont Door Automation dba Piedmont Door Solutions**, to provide On-Site Door Repair and Overhead Door Preventive and Predictive Maintenance Countywide, dated 1st day of January 2022, on behalf of the **Department of Real Estate and Asset Management**; and

WHEREAS, the purpose of this amendment is for the approving of increasing spending authority to cover the costs to complete the on-going replacement/emergency repair project at the Fulton County Justice Center Tower and provide additional preventive maintenance services and on-site door repair services for the remainder of FY2024.

WHEREAS, the Contractor has performed satisfactorily over the period of the contract; and

WHEREAS, this amendment was approved by the Fulton County Board of Commissioners on **July 10, 2024, BOC Items #24-0475**.

NOW, THEREFORE, the County and the Contractor agree as follows:

This Amendment No. 1 to Form of Contract is effective as of the 10th day of July 2024, between the County and **Piedmont Door Automation, dba Piedmont Door Solutions**, who agree that all Services specified will be performed in accordance with this Amendment No. 1 to Form of Contract and the Contract Documents.

1. **SCOPE OF WORK TO BE PERFORMED:** To cover the costs to complete the on-going replacement/emergency repair project at the Fulton County Justice Center Tower located at 185 Central Ave, Atlanta, GA 30303 and provide additional

preventive maintenance services and on-site door repair services for the remainder of FY2024.

4. **EFFECT OF AMENDMENT NO. 1 TO FORM OF CONTRACT:** Except as modified by this Amendment No. 1 to Form of Contract, the Contract, and all Contract Documents, remain in full force and effect.

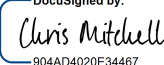
