

AMENDMENT NO. 1 TO FORM OF AGREEMENT

This Amendment 1 to the Statewide Contract Agreement is made and entered into this day of September 2024, between Fulton County, Georgia, a political subdivision of the State of Georgia, hereinafter referred to as "County" and **DOVER STAFFING, INC.** hereinafter referred to as "Agency", authorized to transact business in the State of Georgia.

W I T N E S S E T H

WHEREAS, the County entered into a Contract with Agency to provide temporary staffing services for the Department of Registration and Elections to include the General Election and the General Run-off Elections; and

WHEREAS, the County wishes to amend the existing Agreement to add Flipper Temple AME Church and the Fulton County Government Center as Advance Voting locations for the full three week advance voting period; to add twenty (20) temporary staffing positions to properly staff the additional Advance Voting locations and to reallocate the current approved funding; and

WHEREAS, to correct the Contract Agreement that the Agreement was approved by the Fulton County Board of Commissioners on July 10, 2024, BOC Item 24-0472; and

WHEREAS, the Agency has performed satisfactorily over the period of the contract; and

WHEREAS, this amendment was approved by the Fulton County Board of Commissioners on September 18, 2024, BOC Item 24-0618.

NOW, THEREFORE, the County and the Agency agree as follows:

This Amendment No. 1 to Form of Contract is effective as of the day of September 2024, between the County and the Agency who agree that all Services specified will be performed in accordance with this Amendment No. 1 to Form of Contract and the Emergency Authorization Agreement.

1. **SCOPE OF WORK TO BE PERFORMED:** To amend the existing Agreement to add two Advanced Voting locations; to add twenty (20) temporary staffing positions to properly staff the two Advanced Voting locations and to reallocate the current approved funding.
2. **COMPENSATION:** No additional cost.
3. **LIABILITY OF COUNTY:** This Amendment No. 1 to Form of Agreement shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the County and delivered to Agency.
4. **EFFECT OF AMENDMENT NO. 1 TO FORM OF AGREEMENT:** Except as modified

by this Amendment No. 1 to Form of Agreement and the Agreement, and all Agreement Documents, remain in full force and effect.

CONSUMER DISCLOSURE

From time to time, Carahsoft OBO Fulton County, Georgia (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
