1. Describe what efforts were made to reduce the scope and cost of this contract.

Efforts to reduce the scope and cost of this contract included an evaluation of previous solicitations, which failed to attract qualified providers due to the specialized nature of the services. Recognizing the essential expertise required, the contracting process was refined to focus on leveraging an organization with established capacity and infrastructure to deliver these specialized services effectively. The Atlanta Legal Aid Society was identified as a uniquely qualified partner due to its extensive history and proven track record in providing civil legal aid to low-income individuals across metro Atlanta. Its existing network of neighborhood offices, hospital partnerships, courthouse collaborations, self-help clinics, and community education programs creates economies of scale that reduce overhead costs. The organization's ability to handle over 20,000 cases annually with a combination of 90 attorneys and over 700 volunteers ensures cost-effective service delivery without compromising quality or accessibility. Additionally, by collaborating with an established provider like Atlanta Legal Aid, the need for duplicative administrative or operational investments was minimized. This approach ensures efficient use of resources while maintaining the specialized support necessary for self-represented individuals.

The in person and virtual attorney consultations, clinics, seminars, legal forms, and other court related services offered by the JRC and ALAS provide citizens with a strong foundation and support for navigating through the court system. Without an approved legal assistance contracted program, many citizens would not have access to justice within the Fulton County court system.
