Bill/Author	Description	Status
HB 112 COVID-19 Liability: Extend Business and Government Immunity until 2022 – Rep. Kelley R-16 (Cedartown)	This bill extends protections for limited liability claims passed in the 2020 "Georgia Pandemic Business Safety Act" for one year through July 14, 2022. The Act provides that businesses, health care providers, and local governments cannot be sued for the transmission, infection, exposure or potential exposure of COVID-19 unless the local government, business, or other entity was grossly negligent, engaged in willful and wanton misconduct, or recklessly or intentionally inflicted harm.	House Passed (99-68)
HB 290 Right to Visit Act – Rep. Setzler R-35 (Acworth)	This bill requires hospitals and long-term care facilities to allow a legal representative of a patient staying for more than 12 hours to visit the patient's bedside at least one hour daily, including during a declared public health emergency.	House Passed by Substitute (113-57)
HB 653 Georgia Pharmacy Practice Act – Rep. Jasperse R-11 (Jasper)	This bill allows pharmacists at a pharmacy or other facility to continue to conduct COVID-19 tests for 12 months after the end of the public health emergency declared by the United States secretary of health and human services.	House Passed by Substitute (170-0)
SB 46 Authorize Emergency Medical Technicians to Administer Vaccines – Sen. Burke R-11 (Bainbridge)	This bill authorizes Emergency Medical Technicians and Cardiac Technicians to administer vaccines in public health emergencies. The bill also requires reporting to the Department of Public health regarding vaccinations.	On Second Read - House Health and Human Services

HB 445 - City of South Fulton; change corporate boundaries – Rep. Bruce D-61 (Atlanta)	This bill changes the corporate boundaries of the City of South Fulton to include the Fulton Industrial District except the Fulton County Executive Airport - Charlie Brown Field and contiguous Fulton owned properties.	House Passed (154-0); Referred to Senate State and Local Governmental Operations
HB 459 Local government; prohibit annexations of county operated airport property – Rep. Martin R-49 (Alpharetta)	This bill prohibits a municipality that contains more than 85 square miles within its corporate limits from annexing any territory on which a public airport operated by a county is located unless the governing authority of such county adopts a resolution approving such annexation within 90 days prior to the governing authority of the municipality holding a vote on such annexation.	House Passed (168-0); Referred to Senate State and Local Governmental Operations
SR 84 Joint Study Committee: Airport Infrastructure and Improvements – Sen. Harper R-7 (Ocilla)	This resolution creates the Joint Study Committee on Airport Infrastructure and Improvements that will study airport funding and policies in order to support the growth of the aviation industry.	Senate Adopted By Substitute (41-8); First Read in House Transportation Committee

HOMEOWNER PROTECTIONS

 HR 117 House Study Committee on Homeowners' Associations, Condominium Owners' Associations, and Property Owners in Community Associations – Rep. Boddie D-62 (East Point): This resolution creates the five member House Study Committee on Homeowners' Associations, Condominium Owners' Associations, and Property Owners in Community Associations. This committee will study how various communities could be better organized to implement requirements and procedures for turnover and transition from declarants, developers, or other establishing entities to property owners comprising the community association.

Dixon R-45 (Buford)	This bill allows survivors of human trafficking to recover damages and reasonable attorney's fees in a court of law against traffickers. Companion bill Did NOT Pass: HB 177 Torts; provide a cause of action against perpetrators for victims of human trafficking – Rep. Bonner R-72 (Fayetteville); On Second Read – House Judiciary Committee	Senate Passed (50-0)
SB 34 Domestic Relations; name change; victims of human trafficking may petition – Sen. Dixon R-45 (Buford)	This bill allows privacy for name changes (non-disclosure waiver) for persons formerly trafficked. Companion bill Did NOT Pass: HB 178 Domestic relations; victims of human trafficking may petition for name change under seal – Rep. Bonner R-72 (Fayetteville); On Second Read – House Judiciary Committee	Senate Passed (50-0)

Omnibus Elections – House of Representatives

- HB 531 Elections; Omnibus Bill Rep. Fleming R-121 (Harlem): Bill highlights include:
 - Mobile voting unit restrictions use in emergency situations to supplement existing polling places
 - No election superintendents or boards of registrars can accept private funding
 - Absentee ballot drop box deployed by population formula (1 box per every 100K voters); inside polling site
 - Absentee application ID requirements (eliminates signature match)
 - Weekend Advance Voting: Between 9am 5pm on either the third Saturday or third Sunday prior to Election Day
 - Schedules run-off elections four weeks after election
 - SOS will serve as ex-officio, non-voting member of State Election Board; new nonpartisan chairperson elected by Legislature
 - Bans non-governmental grant funding
 - Disqualifies provisional ballots cast at wrong precinct

Includes five of ACCG's election priorities listed below: ACCG Summary

- Allowing county flexibility in reducing the 1/250 voting machine mandate in certain elections
- Authorizing poll workers to serve in an adjoining county from where they live or are employed
- Changing the absentee ballot application receipt deadline (second Friday before Election Day)
- Allowing counties to start processing and scanning absentee ballot earlier
- Authorizing counties to employ absentee ballot drop boxes, which is currently not in the GA Code

Omnibus Elections – Senate

- SB 241 Elections and Voting; revise comprehensively Sen. Dugan R-30 (Carrollton) Bill highlights:
 - Attorney General Voter Hotline for voter intimidation and illegal election complaints
 - Weekend Early Voting 9am 4pm (not required if no federal candidates)
 - Mobile voting units used in emergencies only—Superior Court Judge approval within 2,640 feet of the existing polling place and with same disability accommodations
 - Absentee ballots only available to voters age 65 +, voters w/disability or who will be out of town on Election Day
 - Absentee ballot application ID requirements; daily reporting to SOS Office
 - Begin scanning (but not tallying) Absentee ballot on second Monday before Election
 - Eligible voters who are in detention centers may be allowed to vote by Absentee ballot
 - Low-performing Superintendents may be removed by State Elections Board if remediation fails (language from Senate approved SB 89)
 - Poll hours are not permitted to be extended except by order of a judge upon good cause
 - Emergency rules by State Elections Board may be overturned by Senate/House Judiciary Comm.

Williamson R-115 (Monroe)	This preemption legislation prohibits any Georgia local government from adopting any policy that prohibits, or has the effect of prohibiting, the connection or reconnection of any utility service based on the type or source of energy or fuel to be delivered to any customer. Local governments may still choose utility services for the properties they own.	House Passed (103- 62); Referred to Senate Regulated Industries and Utilities Committee
HB 435 Bids; Public Works Construction Projects Exception – Rep. Anderson R- 10 (Cornelia)	Current law requires all local government public works construction contracts valued at over \$100,000 to go out for public bid. This bill allows an exception for contracts that were competitively procured by the state or through a cooperative purchasing organization, certified by the state as a source of supply.	House Passed by Substitute (157-9)
HB 465 Prohibit Local Governments from Issuing Civil Fines for False Alarms – Rep. Gullet R-19 (Dallas)	This bill prohibits local governments from imposing civil penalties upon an alarm systems contractor for a false alarm that occurs through no fault of the alarm systems contractor. In cases where the alarm system contractor was in compliance with such provisions, a local government may require that individual property owner responsible for the false alarm pay for or be responsible for any fines, fees, or other penalties relative to false alarms. Additionally, this bill exempts certain cybersecurity documents from open records requirements.	House Passed (170-0)
HB 156 Locals Must Report Cyber Attacks, Executive Session and Open Records – Rep. Parsons R-44 (Marietta)	This legislation requires counties and cities to report certain cyberattack, data breach or malware incidents to the state director of emergency management and homeland security. Incidents are to be reported if they create a life-safety event, substantially impact the security of data and information systems, or affect critical systems, equipment or service delivery.	House Passed (163-0)
SB 52 Cybersecurity; Affirmative Defense to Liability for Businesses – Sen. Thompson R-14 (White)	This bill provides standards for cybersecurity programs to protect businesses from liability while providing for affirmative defenses for data breaches of private information. Mainor D-56 (Atlanta)	This bill requires each county and municipal law enforcement agency to post on the agency's website on a monthly basis a summary or listing of certain crimes which were reported to or investigated by such law enforcement agency that occurred on or in certain property which is used as an apartment building or apartment complex. The law enforcement agency shall maintain such reports on its website for a period of at least two years for the information of the public and make paper copies of such information available to the public. HB 272 Increase Juvenile Court Jurisdiction from Age 17 to Age 18 – Rep. Ballinger R-23 (Canton)	This bill increases Juvenile Court Jurisdiction from Age 17 to Age 18. The bill also creates a ten member Juvenile Offenders Citation Committee.	House Passed by Substitute (113- 51)
HB 371 Allow Certain Court Proceedings be conducted via Video Conferencing – Rep. Gunter R-8 (Blairsville)	This bill allows certain court proceedings to be conducted via video conferencing in local jails.	House Passed by Substitute (157-9)
HB 479 Citizens Arrest Law (repeal and replace) – Rep. Reeves R-34 (Marietta)	This bill repeals the Citizens Arrest Law, removing the current law provision that allows for a private citizen to detain another private citizen on the basis of reasonable suspicion a criminal activity occurred. Exceptions for business owners, retail/restaurant employees and private security officers in the cases of detaining individuals for shoplifting or theft are provided. For chief magistrates, the new minimum salary is equal to the previous minimum salary, plus previously enacted cost-of-living adjustments, plus an additional five percent raise. Monthly minimums for magistrate court clerks are increased by the same percentage. For counties with a population of 500,000 or more, the new minimum salary, beginning January 1, 2022, will be \$133,106.73. HB 579 Public Safety and Judicial Facilities Act – Rep. Oliver D- 82 (Decatur)	This bill would remove the requirement for referendum approval of bonds issued by a county or city Public Safety & Judicial Facilities Authority located within a county that levies a sales tax for a metropolitan area system of public transportation (DeKalb, Fulton, and Clayton). Such authorities are authorized to issue bonds to finance facilities such as detention facilities, court-related facilities, and public safety facilities.	House Passed (169-0)

Currently, probate judges in roughly 30 counties also serve as elections superintendents and if they become unable to serve, the chief probate clerk would certify the election. This list shall be provided to the county free of charge. Counties would have to remove deceased persons from the voting rolls.	Senate Passed (48-5)
SB 74 Elections; Expand Poll Watcher Access Expansion – Sen. Mullis R-53 (Chickamauga)	This bill provides access for poll watchers to all areas in tabulating centers to observe the vote counting process. Restrictions of movement and activities of poll watchers, in order to provide for the security of the ballots and to prevent tabulating interference, by the election superintendent is allowed but should be minimal. SB 89 Elections; Low Performing Election Superintendents Can be removed by State – Sen. Miller R-49 (Gainesville)	Bill establishes the position of chief elections assistance officer within the Secretary of State's Office who will support and assist county election superintendents, including their training; investigate the causes of low performance and lack of adherence to election laws and procedures; offer support services to improve performance. Within 90 days of the evaluation, if the county superintendent is still in violation of the criteria determined by the State Election Board that superintendent may be suspended and replaced by the Board. Cowsert R-46 (Athens)	This bill requires the Secretary of State to establish and maintain an election results reporting system for primary, general and runoff elections. The system shall provide for the entry of the number of ballots cast by type in each precinct, the results of state and federal races by precinct, the number of absentee ballots issued and returned, the number of absentee ballots certified, the number of absentee ballots rejected, the number of provisional ballots cast, and other information the SOS deems relevant to be made available to the public. SB 253 Elections; notice when polling places are relocated – Sen. Merritt D-9 (This bill requires election superintendents to notify electors of a change in a polling place during the seven days before and on the date of the first election following the change. HB 370 Term Limits for Joint Hospital Authority Members – Rep. Jones R- 47 (Milton)	This bill states that no person shall serve as a member of a joint hospital authority for more than three consecutive terms, including any partial term, or 12 years, whichever is longer.	House Passed (105-59)
SB 164 HIV Tests; modernization of HIV related laws to align with science provide – Sen. Hufstetler R-57 (Rome)	This bill amends Code Section 15-11-471, Title 16, and Code Section 31-22-9.1 of the O.C.G.A., relating to definitions relative to juvenile delinquency, crimes and offenses, and who may perform HIV tests, respectively, so as to provide for the modernization of HIV related laws to align with science to ensure that laws and policies support current understanding of best public health practices for preventing and treating HIV, scientific evidence about routes of transmission, and the public health goals of promoting HIV prevention and treatment; to provide for related matters; to repeal conflicting laws; and for other purposes. Bill extends Hotel-Motel Tax to Airbnb and similar shelter rentals. Extended stay rentals shall be exempt from the tax levied by this Code section. SB 6 "Tax Credit Return on Investment Act of 2021" – Sen. Albers R- 56 (Roswell)	This bill allows for analysis of the costs and benefits from state laws that provide tax exemptions, credits, deductions, and abatements. Each year, the chairs of the House Ways & Means Committee and Senate Finance Committee could request an economic analysis of up to five existing or proposed tax expenditure laws. The analysis would consider the costs to the state from the law, along with any public benefits flowing from that law.	Senate Passed

HB 75 Property Tax: Clarify Millage Rate Notification Requirements – Rep. Gambill R-15 (Cartersville)	This bill revises the confusing language of the public notice that must be published when a local government proposes a property tax millage rate that exceeds the "rollback rate". The rollback rate is the millage rate that would generate the same revenue as in the prior year, taking into account inflationary increases in the tax digest. HB 75 would clarify that while a proposed millage rate that is higher than the rollback rate would result in overall higher government tax revenue, an individual property owner's taxes may or may not go up. The notice language proposed in this bill would provide the property owner with clearer information on how to calculate his/her taxes. Additionally, HB 75 would allow any local government that has a "floating" homestead property tax exemption to dispense with the otherwise applicable public notification of tax increase requirements. HB 281 Mandatory Notice from Probate Court of Expiration of Weapons Carry License – Rep. Burchett R- 176 (Waycross)	This bill mandates that probate court judges provide notice of expiration to all weapons carry license holders not more than 90 days in advance or less than 30 days from expiration. Hogan R-179 (St. Simon's Island)	This bill establishes a three-year assisted outpatient treatment grant program, subject to appropriations, with the full expectation that the program will establish the efficacy of the assisted outpatient treatment model in Georgia and serve as a first step toward full integration of assisted outpatient treatment into the routine activities of community service boards and probate courts across the state. The bill also establishes an eight member assisted outpatient treatment advisory council.	On Second Read - House Health & Human Services Committee

SB 171 Safe Communities Act of 2021 – Sen. Robertson R-29 (Cataula)	This bill allows for several new types of lawsuits against counties and would impose various new mandates and limitations on county operations. Highlights include: Section 3 - This section also allows for lawsuits for monetary claims for injuries/damages against a county or city governing authority that is "grossly negligent by allowing the commission of violence against persons or property during an assembly of two or more persons." Section 6 - Provides that any county/city that reduces its law enforcement budget by 30% or more in a year would be subject to the withholding of state funds and state-administered federal funds. This section also states the governing authority of a county or city that intentionally obstructs or interferes with the ability of a county or city law enforcement agency to provide reasonable law enforcement protection during a riot or unlawful assembly shall be civilly liable for any personal injury, death, or property damages proximately caused by the agency's failure to provide reasonable law enforcement protection during the riot/unlawful assembly. County and city sovereign immunity is waived as to such claims for damages.	Referred to Senate Judiciary Committee

- HB 352 Property Tax: New Statewide Homestead Exemption and Changes to Tax Assessment and Billing – Rep. Momtahan R-17 (Dallas): This bill makes sweeping changes to the property tax system for counties, cities, and school systems including:
 - Extending the appeal window from 45 days to 180 days
 - Making the Chief Appraiser an elected position
 - Implementing a statewide CPI-based floating homestead exemption.

Public transportation definition includes: roads, bridges, rails, airports, buses, seaports, and all accompanying infrastructure and services necessary to provide access to these public transportation facilities. SR 100 State-Wide Grand Juries; jurisdiction, powers, and duties – Sen. Gooch R-51 (Dahlonega)	This proposed constitutional amendment mandates state-wide grand juries in cases of Elections crimes upon petition of the Attorney General to the Supreme Court. A state-wide grand jury shall consist of not fewer than 13 nor more than 23 persons. The Chief Justice of the Supreme Court shall designate a superior court judge to act as presiding judge for each state-wide grand jury. The jurisdiction of a state-wide grand jury shall extend throughout the state, and it may investigate and return indictments for crimes committed anywhere within the state. The term of any such state-wide grand jury shall not exceed 12 months.	Senate Tabled
