WITNESSETH

WHEREAS, Fulton County ("County") entered into a Contract with Veolia North America – South, LLC, to provide operation and maintenance services for the Camp Creek water reclamation facility and associated pump stations in South Fulton County, dated 21st day of December 2016, on behalf of the Department of Public Works; and

WHEREAS, the County wishes to amend the existing contract to increase the spending authority to cover the added cost of disposing of biosolids and increased maintenance activities at the Camp Creek facility in accordance with the contract; and

WHEREAS, the Contractor has performed satisfactorily over the period of the contract; and

WHEREAS, this amendment was approved by the Fulton County Board of Commissioners on December 17, 2025, BOC Item

NOW, THEREFORE, the County and the Contractor agree as follows:

This Amendment No. 2 to Form of Contract is effective upon BOC approval, through March 31, 2026, or until services are no longer required as determined by Fulton County. This Amendment is entered into by and between Fulton County and Veolia North America – South, LLC, who agree that all services specified shall be performed in accordance with this Amendment No. 2 and the Contract Documents.

1. **SCOPE OF WORK TO BE PERFORMED:** The 2025 operations have experienced increased costs in biosolid disposal (actual costs of \$135/wet ton as compared to the planned \$95/wet ton) and increased maintenance activities (specifically, pump replacements and SCADA upgrades in managed assets) an

additional \$890,000 is requested to cover these costs. Public Works staff have reviewed the additional costs and agree that they are reasonable and needed for the successful operation of the Camp Creek facilities.

As part of the 2026 Operation & Maintenance contract and Purchase Order #540 16RFP071816K-DJ YR25), Veolia North America – South, LLC is authorized to perform \$10,056,888.00 worth of work necessary to properly operate and maintain the Camp Creek wastewater treatment facility and the associated lift stations throughout South Fulton. The 2025 operations have experienced increased costs in biosolid disposal (actual costs of \$135/wet ton as compared to the planned \$95/wet ton), increased maintenance activities (specifically, pump replacements and SCADA upgrades in the managed assets), as explained above, and additional operational support associated with the Camp Creek primary and secondary clarifier repair and the Graham Drive Lift Station modernization construction projects. Public Works staff have reviewed the additional costs and agree that they are reasonable and needed for the successful operation of the Camp Creek facilities. Money is available for these expenses in the existing 2025 Public Works O&M budget and capital program.

- 2. **COMPENSATION:** The services described under Scope of Work herein shall be performed by Contractor in an amount not to exceed \$3,677,254.20 (Three Million Six Hundred Seventy-Seven Thousand Two Hundred Fifty-Four Dollars and Twenty Cents) approved by BOC.
- 3. **LIABILITY OF COUNTY:** This Amendment No. 2 to Form of Contract shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the Chair to the Commission, attested to by the Clerk to the Commission and delivered to Contractor.
- 4. **EFFECT OF AMENDMENT NO. 2 TO FORM OF CONTRACT:** Except as modified by this Amendment No 2 to Form of Contract, the Contract, and all Contract Documents, remain in full force and effect.
