

1 A RESOLUTION APPROVING A PARKING SPACE LICENSE AGREEMENT  
2 BETWEEN FULTON COUNTY, GEORGIA AND LANIER PARKING HOLDING, INC.,  
3 D/B/A LANIER PARKING SOLUTIONS, FOR THE PURPOSE OF PROVIDING  
4 PARKING FOR THE FULTON COUNTY SUPERIOR COURT ADMINISTRATION AND  
5 RELATED SERVICES; AUTHORIZING THE CHAIRMAN TO EXECUTE THE LICENSE  
6 AGREEMENT AND RELATED DOCUMENTS; AUTHORIZING THE COUNTY  
7 ATTORNEY TO APPROVE THE LICENSE AGREEMENT AND RELATED  
8 DOCUMENTS AS TO FORM AND TO MAKE ANY MODIFICATIONS THERETO PRIOR  
9 TO EXECUTION; AND FOR OTHER PURPOSES.

10 WHEREAS, the mission of the Superior Court of Fulton County is to protect rights  
11 and liberties, uphold and interpret the law, and provide for the peaceful resolution of  
12 disputes; and

13 WHEREAS, Fulton County Superior Court Administration is responsible for all non-  
14 judicial functions of the Superior Court of Fulton County, Atlanta Judicial Circuit, 5<sup>th</sup>  
15 Judicial Administrative District, including case flow management, Human Resources  
16 management, fiscal administration, technology management, planning and research, jury  
17 management, Alternative Dispute Resolution and Business Court services, space  
18 management, intergovernmental and community relations, public information services,  
19 court reporters, court interpreters, ADA reasonable modifications and the management  
20 of all Court functions and programs; and

21 WHEREAS, it is the desire of Fulton County to enter into a Parking Space License  
22 Agreement with Lanier Parking Holding, Inc., d/b/a Lanier Parking Solutions in order to  
23 ensure accessible parking for staff and Fulton County vehicles required to provide court  
24 services for all constituents served by the Fulton County Superior Court Administration;  
25 and

26 WHEREAS, pursuant to O.C.G.A. § 36-60-13, the County is authorized to enter  
27 into multiyear lease, purchase, or lease purchase contracts of all kinds for the acquisition  
28 of goods materials, real and personal property, services and supplies.

29 NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners hereby  
30 approves the Parking Space License Agreement with Lanier Parking Holding, Inc., d/b/a  
31 Lanier Parking Solutions, in substantially the form attached hereto as Exhibit "A."

32 BE IT FURTHER RESOLVED, that the Chairman of the Board of Commissioners  
33 is hereby authorized to execute the Parking Space License Agreement and related  
34 documents between Fulton County and Lanier Parking Holding, Inc., d/b/a Lanier Parking  
35 Solutions.

1        **BE IT FURTHER RESOLVED**, that the County Attorney is hereby authorized to  
2 approve the Parking Space License Agreement as to form and to make such other or  
3 additional modifications as are necessary to protect the County's interests prior to  
4 execution by the Chairman.

5        **BE IT FINALLY RESOLVED**, that this Resolution shall become effective upon its  
6 adoption, and that all resolutions and parts of resolutions in conflict with this Resolution  
7 are hereby repealed to the extent of the conflict.


