Scope of Work: This request is for the purchase of 5 police pursuit vehicles for the Fulton County Police Department.

The cost per vehicle includes 3 year/36,000 mile maintenance warranty which covers the following vehicle components: engine, transmission, rear-wheel drive, front wheel drive, steering, brakes, front suspension, electrical, air conditioning and heating, high tech components, emission system components, audio and safety system components. Everyday maintenance, fluids, lubrication, brake pads, wiper blades, etc., are not covered under the warranty.
