Problem:

How do we improve our Constituent Experience to find destinations, provide multiple sources of information as to the services provided by the County, and improve our Branding?

Answer:

Introduce a systematic Wayfinding approach which:

- 1. Updates and Improves FC Branding
- 2. Enhances notifications locating services needed
- 3. Better Identifies Destination Locations Exterior and Interior
- 4. Provides Supplemental Tools On Site



Phase 1

- Prioritize Courts First
- Team Approach
- Allied Paths to Courts from Government Center

Phase 2

- Improve Government Center and Public Safety Building Exterior Signage
- Improve Government Center and Public Safety Building Interior Signage
- Design and Develop Signage for Fabrication for Assembly Hall Area

Phase 3

- MORE FULLY Develop Processes and Administration, to Ensure Our Investment is Current, Effective, Efficient and Becomes the Standard, Going Forward
- Consider Other Appropriate FC Locations for Wayfinding Treatment



Phase 2 Proposals:

- 1. Address the Government Center and Public Safety Building Exterior Signage
 - Designs Developed by Selbert Perkins, Priced by DeNyse, and Submitted to the BOC on the April 14th Agenda.
 Spending Authority Requested from BOC \$53,078.71
 - *NOTE: Capital Committee Approved on 2-26
- 2. Survey the Interior of the Government Center and Public Safety
 Building, to determine the Digital and Static Signage Necessary
 to Present a Cohesive and Comprehensive Wayfinding Approach
 which Continues to Improve the Customer Experience
 - Proposal received from Selbert Perkins 3/1/21



<u>Summary of Proposal from Selbert Perkins for Government Center and Public Safety</u> **Building**

Step 1 – Analysis/Survey

- Kickoff Meeting Site Survey
- Study Circulation Patterns and ID Destinations Needing Direction to the General Public
- Evaluate Existing Architectural Conditions and How Wayfinding System In Courts Needs to be Updated for the Government Center/Public Safety Bldg.

Deliverables:

- Existing Conditions Report Documenting Survey and Initial Recommendations
- Preliminary Sign Type and Location Plan for Levels 1-4

<u>Building</u>

Step 2 – Programming/Bid Packages

- Utilizing Sign Types Developed for The Courts
 - Identification
 - Department Signs, Room Signs, Restroom Signs, Café, Elevators, etc.
 - Direction Signs
 - Overhead, Wall Mounted and Freestanding
 - Information Signs
 - Digital and/or Static Directories, Changeable Information Signs
 - Regulatory Signs
 - Code Required Signs such as Stairwells, Evacuation Maps, etc.
- Document Sign Location Plans
- Prepare Bid Package to accompany Sign Location Plans, including Design Drawings of Wayfinding Signs used in the Government Center/Public Safety Complex
- Provide Estimated Cost for Sign Fabrication and Installation and Work with the County on an Implementation
