WHEREAS, Fulton County (“County”) entered into a Contract with Gresham Smith & Partners (“Gresham Smith”) to provide standby engineering services, dated August 1st, 2018, on behalf of the Public Works Department; and

WHEREAS, the Public Works Department is seeking an increase in spending authority in order to close-out the contract; and

WHEREAS, the Contractor has performed satisfactorily over the period of the contract; and

WHEREAS, this amendment was approved by the Fulton County Board of Commissioners on June 21st, 2023 under Agenda Item No. 23- .

NOW, THEREFORE, the County and the Contractor agree as follows:

This Amendment No. 1 to Form of Contract is effective as of the 21 day of June 2023, between the County and Gresham Smith, who agree that all Services specified will be performed in accordance with this Amendment No. 1 to Form of Contract and the Contract Documents.

1. **SCOPE OF WORK TO BE PERFORMED:** To provide standby engineering services.
2. **COMPENSATION:** The services described under Scope of Work herein shall be performed by the Contractor for a total amount not to exceed \$15,188.00 (Fifteen Thousand One Hundred Eighty Eight Dollars and No Cents) with Gresham Smith . This action will increase the total contract amount to \$1,515,188.00.

3. **LIABILITY OF COUNTY:** This Amendment No. 1 to Form of Contract shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the Chair to the Commission, attested to by the Clerk to the Commission and delivered to Contractor.

4. **EFFECT OF AMENDMENT NO. 1 TO FORM OF CONTRACT:** Except as modified by this Amendment No. 1 to Form of Contract, the Contract, and all Contract Documents, remain in full force and effect.
