Four (4) qualified firms submitted proposals for evaluation and consideration for award of the Account Based Plan section of this project:

1. Aetna Life Insurance Company
2. Cigna Health and Life Insurance Company
3. Blue Cross Blue Shield Healthcare Plan of Georgia, Inc.
4. Kaiser Foundation Healthcare Plan of Georgia Permanente

After review, evaluation and consideration of all available information related to the requirements and evaluation criteria of the RFP, the Evaluation Committee has determined that the proposal submitted by Blue Cross Blue Shield Healthcare Plan of Georgia, Inc. with a total score of 81.82, is the recommended self-insured vendor for the award of 24RFP050124C-MH, Employee Healthcare Benefits Plan Services (Medical Rx). The Evaluation Committee has also determined that the proposal submitted by Kaiser Foundation Healthcare Plan of Georgia Permanente with a total score of 78.95, is the recommended fully insured vendor for the award of 24RFP050124C-MH, Employee Healthcare Benefits Plan Services (Medical Rx).
