

### Per Diem Background

Permitted by Development Authorities Law

Working with Fulton County legal department for date authorized by BOC

- May have been 25 plus years ago
  Shared memo/documentation from 2011 that shows the BOC was informed of all boards and per diems, including DAFC
- Posted on Fulton County website for years along with other boards and their respective per diems/stipends

## Per Diem Moving Forward

#### **BOC** has found per diems/stipends to be reasonable for other boards:

- AUDIT COMMITTEE \$250 per meeting
- BOARD OF ETHICS \$150 per meeting
- BOARDS OF EQUALIZATION \$100 per member per day served
- FULTON COUNTY BOARD OF TAX ASSESSORS \$1500 per month
- FULTON COUNTY BOARD OF ZONING APPEALS \$150 per meeting
- METROPOLITAN ATLANTA RAPID TRANSIT AUTHORITY(MARTA) \$105 per meeting



# Per Diem Moving Forward

#### > Development Authorities Law states:

- BOC determines the amount of the per diem
  - DAFC not processing per diems until BOC decision
- Board members shall be paid a per diem for each day, or part thereof, spent in the performance of their duties
  - Board Meetings
  - Working Committees MFBE Review, Strategic Initiatives
  - Site visits
- Its provisions shall be liberally construed and shall be controlling over any laws that are otherwise inconsistent
