A RESOLUTION TO AMEND FULTON COUNTY POLICY AND PROCEDURE 600-71 REGARDING DEDICATION PLAQUES FOR COUNTY FACILITIES TO AUTHORIZE LISTING THE NAMES OF THE BOARD OF COMMISSIONERS, LIBRARY BOARD OF TRUSTEES [ONLY WHEN A LIBRARY FACILITY], COUNTY MANAGER AND COUNTY ATTORNEY SITTING AT THE TIME OF DEDICATION OF THE COUNTY FACILITY IN ADDITION TO THOSE MEMBERS SITTING AT THE TIME OF THE AWARD OF THE ORIGINAL CONSTRUCTION OR PURCHASE CONTRACT; AND FOR OTHER PURPOSES.

WHEREAS, on May 4, 2011, the Board of Commissioners adopted Policy and Procedure 600-71 ("Dedication Plaques for County Facilities"), effective May 1, 2011, (hereinafter "Policy 600-71"), to formally establish uniform and standardized guidelines for the design and installation of dedication plaques for County-owned facilities; and

WHEREAS, Policy 600-71 requires that any new or extensively renovated County-owned facility must contain a commemorative dedication plaque as a means of memorializing and publicizing those individuals and firms responsible for the facility's acquisition, construction, or renovation, with the cost associated with the plaques being included in the overall cost of the project; and

WHEREAS, pursuant to Policy 600-71 as originally enacted, the commemorative dedication plaque must contain the names of the members of Board of Commissioners sitting at the time of the award of the original construction contract or land acquisition, the names of the County Manager and County Attorney sitting at the time of such award, and the Architect of record and General Contractor, among other information; and

WHEREAS, on March 4, 2015, the Board of Commissioners amended Policy 600-71 to provide that the commemorative dedication plaque include, where applicable, the names of each sitting member of Board of Trustees ("BOT") of the Library System at the time of award of the construction contract on all commemorative dedication plaques for the Phase I and Phase II Library System's Facility Master Plan projects; and

WHEREAS, a considerable amount of time can lapse between award of the original construction or purchase contract for a County facility and the completed construction or purchase of a County facility; and

REVISED

WHEREAS, the Board of Commissioners believes that the better practice is to list
both (i) the names of the Board of Commissioners, County Manager, County Attorney
and the Library Board of Trustees [only when a library facility], sitting at the time of the
award of the original construction or purchase contract, and (ii) the names of the Board
of Commissioners, County Manager, County Attorney and the Library Board of
Trustees, if a library facility, sitting at the time of the dedication of the County facility; and
WHEREAS, pursuant to Fulton County Code § 1-117, the Board of
Commissioners has "exclusive jurisdiction and control over directing and controlling
all the property of the county, as they may deem expedient, according to law "
NOW THEREFORE, BE IT RESOLVED, that the Board of Commissioners of
Fulton County, Georgia hereby amends Policy and Procedure 600-71 ("Dedication
Plaques for County Facilities"), paragraph 5 of the "Responsibilities and Procedures"
section, as is set forth in Exhibit "A" hereto, to read as follows:
(5) The following information shall appear on a dedication plaque in listed order:
a). Official seal or logo
b). Official corporate name: Fulton County
c). Facility's official name as approved by the Board of Commissioners
d). The word "Awarded" followed by the year of approval
e). Name of each County Commissioner sitting at the time of award of the
original construction contract or land purchase
i. Chair
ii. Vice-Chair
iii. Remaining members listed in district order
f). County Manager sitting at time of award of original construction contract
or land purchase
g). County Attorney sitting at time of award of original construction contract
or land purchase
h). Only when a library facility, the name of each Library Board of Trustee
member sitting at the time of award of the original construction contract or land
purchase
i).The word "Dedicated" followed by the year of dedication

1	j). Name of each County Commissioner sitting at the time dedication
2	i. Chair
3	ii. Vice-Chair
4	iii. Remaining members listed in district order
5	k). County Manager sitting at time of dedication
6	I). County Attorney sitting at time of dedication
7	m). Only when a library facility, the name of each Library Board of Trustee
8	member sitting at the time of dedication
9	n). Architect of Record
10	o). General Contractor
11	BE IT FINALLY RESOLVED, that this Resolution shall take effect upon its
12	adoption, and all resolutions and parts of resolutions in conflict with this Resolution are
13	hereby repealed to the extent of such conflict.
